The Undersigned your petitioners respectfully represent

as follows:-

THAT WHEREAS: they are the owners of all the real property and described as follows to wit:

Commencing at the North East corner of the North west quarter of the South East quarter of section 21. Twp 14 South, Range 10 East, S.L.M. Thence west 330 feet, Thence S 57046 E 390 feet, Thence North 208 feet to place of beginning;

That the aforesaid property is a tract of land lying contiguous taxthe to the corporate limits of Price, a municipal corporation, of the State of Utah, and is fully described above,

And that it is the desire of your petitioners to annex the said above described property to the said city, Price a municipal corporation, that it may be incorporated into the corporate limits of said city,

And your petitioners hereby further respectfully ask your Honorable body that said petition, plat or map, may receive your immediate and earnest attention and consideration, and that you may vote on the annexation of the said lands, and that if two thirds or more of your Honorable shall vote for said annexation, that an ordinance be prepared and that the same may be taken within the corporate limits of Price, as aforesaid, and that you will instruct the clerk to post the proper notices therefor,

ORDINANCE NO.____.

An Ordinande Declaring the Annexation of and the Extending of the Corporate Limits of Price, Utah over Real Property in Montrose Addition.

BE IT OMDAINED BY THE CITY COUNCIL OF PRICE, UTAH:

Section 1. THAT WHEREAS, more than three-fourths of all the members of the City Council of Price, Utah, on the 5th day of September 1822, voted for the annexation of the hereinafter described part of the Montrose Addition to Price City, Utah, it is hereby declared that the real property lying contiguous to the Corporate Limits of Price, Utah, in what is known as the Montrose Addition to Price City, Utah, and hereinafter described, be and the same is hereby annexed to said Price, Utah, and the limits of said City are hereby extended to embrace the said real property, which is particularly described as follows, to-wit:

Commencing at the Northwest corner of the Northeast quarter of the Southwest quarter of Section 21, Township 14 South, Range 10 Esat of the S. L. B. &. M., thence South 713.8 feet to the South side of "D" Street; thence East along the South side of "D" Street a distance of 310.8 feet; thence North 713.8 feet; thence West 310.8 feet to the point of beginning.

Section 2. That this Ordinance shall take effect and be in force on and after its passage, approval and publication.
