ORDINANCE NO. 1038  
 AN ORDINANCE DECLARING THE ANNEXATION OF, AND EXTENDING OF, THE CORPORATE LIMITS OF THE CITY OF PRICE, COUNTY OF CARBON, STATE OF UTAH, OVER REAL PROPERTY IN THE STERLING ADDITION TO CARBON COUNTY, STATE OF UTAH; THE SAME BEING ALL OF LOTS 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, and PART OF LOT 24, BLOCK 1, ADDITION TO THE COUNTY OF CARBON, STATE OF UTAH.

Section 1. That whereas, more than three-fourths of all the members of the City Council of the City of Price, County of Carbon, State of Utah, on the 8th day of April, A. D. 1940, voted for the annexation of the hereinafter described part of Sterling Addition to the City of Price, County of Carbon, State of Utah; it is hereby declared, that the real property lying contiguous to the corporate limits of the City of Price, County of Carbon, State of Utah, in that is known as the Sterling Addition to the County of Carbon, State of Utah, and hereinafter described, be, and the same is hereby annexed to the said City of Price, County of Carbon, State of Utah, and the limits of the said City are hereby extended to embrace the said real property, which is particularly defined and described as follows, to-wit:

beginning at a point S. 0° 06' E. 713.8 feet from the southwest (SW) corner of the Northeast (NE) quarter of the southeast (SE) quarter of Section Twenty-one (21) Township fourteen (14) South, Range 10 East of L. 5, 4' and running thence S. 0° 06' E. 690.2 feet; thence East 195.8 feet; thence N. 0° 06' W. 490.2 feet; thence West 195.8 feet to the point of beginning, which description includes Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, and part of lot 24, Block 1, Sterling Addition to the City of Price.

Section 2. This Ordinance shall take effect and be in full force and operation 30 days after its publication.
