ORDINANCE NO. 1064

AN ORDINANCE DECLARING THE ANNEXATION OF, AND EXTENDING OF, THE CORPORATE LIMITS OF THE CITY OF PRICE, COUNTY OF CARBON, STATE OF UTAH OVER REAL PROPERTY BEING A PART OF THE PARK DALE ADDITION TO THE COUNTY OF CARBON, STATE OF UTAH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PRICE, COUNTY OF CARBON STATE OF UTAH, AS FOLLOWS:

Section 1. That whereas, more than three-fourths of all the members of the City Council of the City of Price, County of Carbon, State of Utah on the 8th day of October, A. D. 1945, voted for annexation of the hereinafter described property to the City of Price, County of Carbon, State of Utah. It is hereby declared that the real property lying contiguous to the corporate limits of the City of Price, County of Carbon, State of Utah, and hereinafter described part of the Park Dale Addition to the City of Price, County of Carbon, State of Utah, and hereinafter described be and the same is hereby annexed to the said City of Price, Carbon County, State of Utah and the limits of the said City are hereby extended to embrace the said real property which is particularly bounded and described as follows:

Beginning at the Southwest Corner of Block 12 of the said Park Dale Addition; thence north to the Northwest Corner of Block 19; thence west to the Northwest Corner of Block 23; thence west 902.6 feet; thence south 650 feet to the present City limits; which description includes Blocks 11, 20, 21, 22, 23 and 24 of the Park Dale Addition to the City of Price.

Section 2. This ordinance shall take effect and be in full force and operation 20 days after its publication.

Passed by the City Council of Price, and approved by the Mayor, this 8th day of October, A. D., 1945.
