SECTION 2. That part and portion of Third North Street extending

Utah, and more particularly specified as follows:
Beginning at the southeast (SE) corner of Block 10, the (c) of the
Block 10 addition to Carbon Annex to Price City, thence running
South (S) Eighty-nine feet (89'); thence East (E) Two Hundred
Eighty feet (280'); thence North (N) Twenty-five feet (25');
thence West (W) One Hundred Eighty feet (180') to the point
of beginning.
Be it further ordained that the above described lot be the public property
of the City of Price, and that the same be heavily vacated and declared to
be a public street, whalley, alley, or pedestrian way.
