BEG. AT A POINT 720 FT. SOUTH OF THE N.W. COR. OF SEC. 15, T. 14 S., R. 10 E., S. 1/4, B. & M. WHICH IS THE N.W. COR. OF BLOCK D, SOUTH 119 FT., EAST 757 FT., WEST 757 FT., TO THE N.W. COR. OF BLOCK D, AND CONSTITUTING THE FOUR NORTH LOTS OF BLOCKS D & E, AND THE TWO NORTH LOTS OF THE WEST HALF OF BLOCK F, TOGETHER WITH ALLEYS AS SHOWN ON PLAT.
