

ORD INANCE 1177-59

AN ORDINANCE DECLARING THE ANNEXATION OF, AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF PRICE, COUNTY OF CARBON, TATE OF UTAH OVER REAL PROPERTY COMPRISING BLOCKS 1, 4, 7, 8, 10 AND THE EAST HALF OF BLOCK 3, EAST HALF OF BLOCK 9, WEST HALF OF BLOCK 5, AND THE WEST HALF OF BLOCK 6 OF PARK CREST COVE NUMBER 1 OF CARBON COUNTY, STATE OF UTAH:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PRICE, COUNTY OF CARBON, STATE OF UTAH, AS FOLLOWS:

SECTION 1. That whereas, more than two-thirds of all members of the City Council of the City of Price, County of Carbon, State of Utah, on the 13th day of July, A.D. 1959, voted for the annexation of the hereinafter descrubed real property to the City of Price, County of Carbon, State of Utah,

IT IS HEREBY DECLARED THAT THE REAL PROPERTY LYING CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF PRICE, COUNTY OF CARBON, STATE OF UTAH, AND HEREINAFTER DESCRIBED, BE, AND THE SAME IS HEREBY ANNEXED TO THE CITY OF PRICE, COUNTY OF CARBON, STATE OF UTAH, AND THE LIMITS OF SAID CITY OF PRICE, UTAH, ARE HEREBY EXTENDED TO EMBRACE THE SAID REAL PROPERTY WHICH IS PARTICULARLY BOUNDED AND DESCRIBED AS FOLLOWS, TO-WIT:

Commending at the South Quarter Corner of Section 9, Township 14 South, Rance 10 East, Salt Lake Base & Meridian and Running Thence North 89°27' West 745.64 Feet; Thence North 0°19'30" East 1342.03 Feet; Thence South 89°42'30" East 752.49 Feet; Thence South 89°42' East 640 Feet; Thence South 0°37' West 735 Feet; Thence South 17°37'12" West 251.36 Feet; Thence South 0°37' West 370.75 Feet; Thence North 89°26' West 66.5 Feet To place of Beginning.

THE AREA SO ANNEXED CONSISTING OF BLOCKS 1, 4, 7, 8, 10, EAST & OF BLOCK 3, EAST & OF BLOCK 9, WEST & OF BLOCK 5, AND WEST & OF BLOCK 6, PARK CREST COVE NUMBER 1, CARBON COUNTY, STATE OF UTAH, TOGETHER WITH THE STREETS, ALLEYS AND EASEMENTS AS PLATTED AND DESCRIBED IN THE PLAT OF SAID SUBDIVISION ON FILE AND OF RECORD IN THE OFFICE OF THE COUNTY RECORDER OF CARBON COUNTY, STATE OF UTAH.

SECTION II. THAT ALL ORDINANCES, RESOLUTIONS AND ORDERS, OR PARTS THEREOF, IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE, ARE, TO THE EXTENT OF SUCH CONFLICT, HEREBY REPEALED.

SECTION III. THAT THIS ORDINANCE, IMMEDIATELY AFTER ITS ADOPTION AND APPROVAL, BE DEPOSITED IN THE OFFICE OF THE CITY RECORDER OF PRICE, UTAH, AND PUBLISHED ONCE IN A NEWSPAPER PUBLISHED IN AND OF GENERAL CIRCULATION "ITHIN THE CORPORATE LIMITS OF PRICE, UTAH.

SECTION IV. IN THE OPINION OF THE CITY COUNCIL OF PRICE CITY, UTAH, IT IS NECESSARY TO THE PEACE, HEALTH, AND SAFETY OF THE INHABITANTS OF PRICE CITY THAT THIS ORDINANCE BECOME EFFECTIVE IMMEDIATELY.

SECTION V. THIS ORDINANCE SHALL TAKE EFFECT UPON ITS FIRST PUBLICATION.
