


ENGINEERS CERTIFICATE

I FURTHER CERTIFY THAT BY AUTHORITY OF THE OWNERS, I HAVE MADE A SURVEY OF THE TRACT OF LAND SHOWN ON THIS PLAT AND DESCRIBED BELOW, AND HAVE SUBDIVIDED SAID TRACT OF LAND INTO LOTS, STREETS, AND EASEMENTS AS SHOWN ON THIS PLAT AND THAT THIS PLAT IS TRUE AND CORRECT.

ALONG THE GOUTHEAST BOUNDARY OF LOT 240; THENCE N 46°E, 160.00 FT. ALONG THE GOUTHEAST BOUNDARY OF LOT 239; THENCE H74°30'E, 123.00 FT. ALONG THE GOUTHEAST BOUNDARY OF LOT 236; THENCE 5 13°E, 101.19 FT. ALONG THE GOUTHWEST BOUNDARY OF LOT 215; THENCE 942°E, 86.71 FT. ALONG THE GOUTH WEGT BOUNDARY OF LOT 214 TO THE POINT OF BEGINNING.
