ANNEXATION PLAT

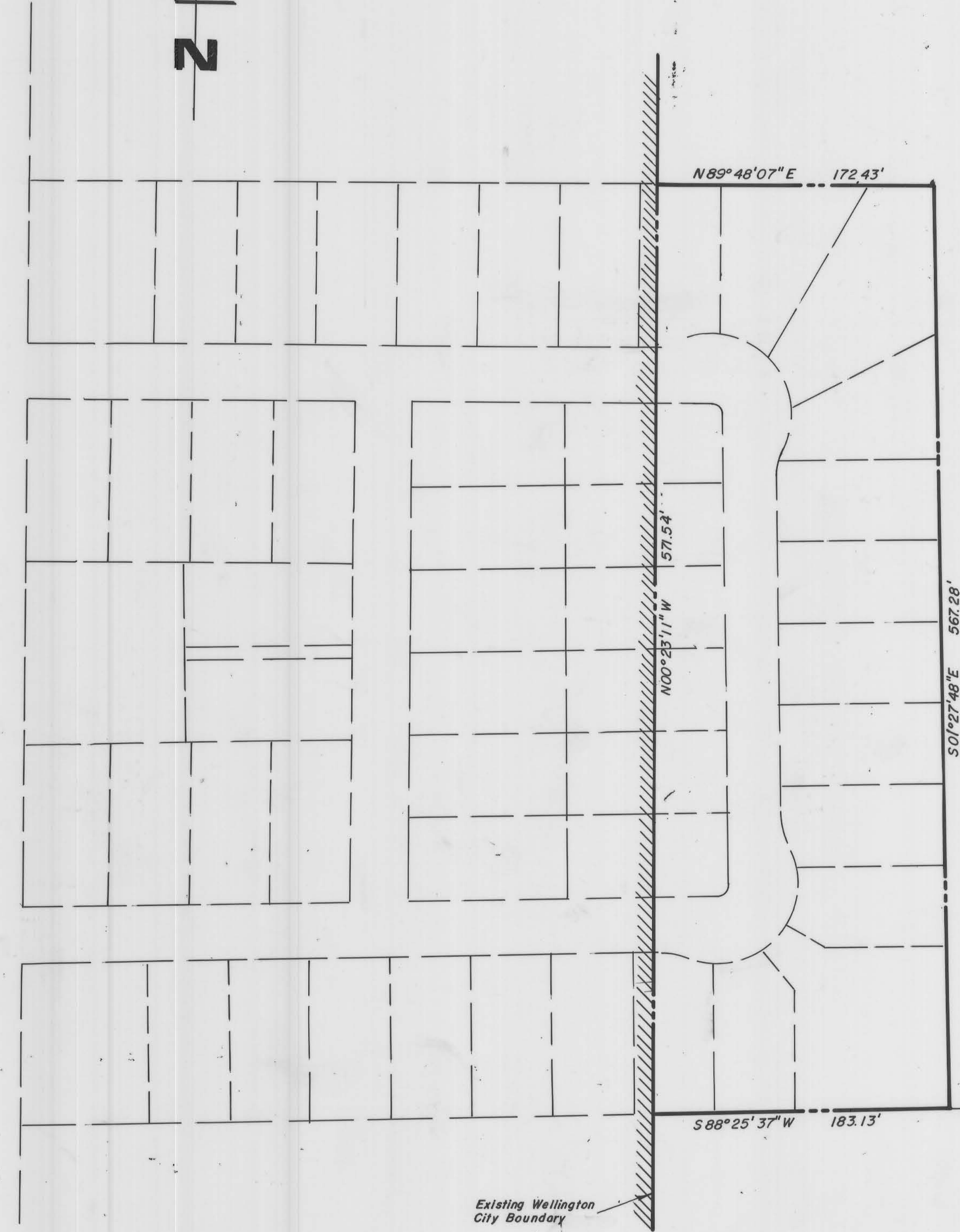
