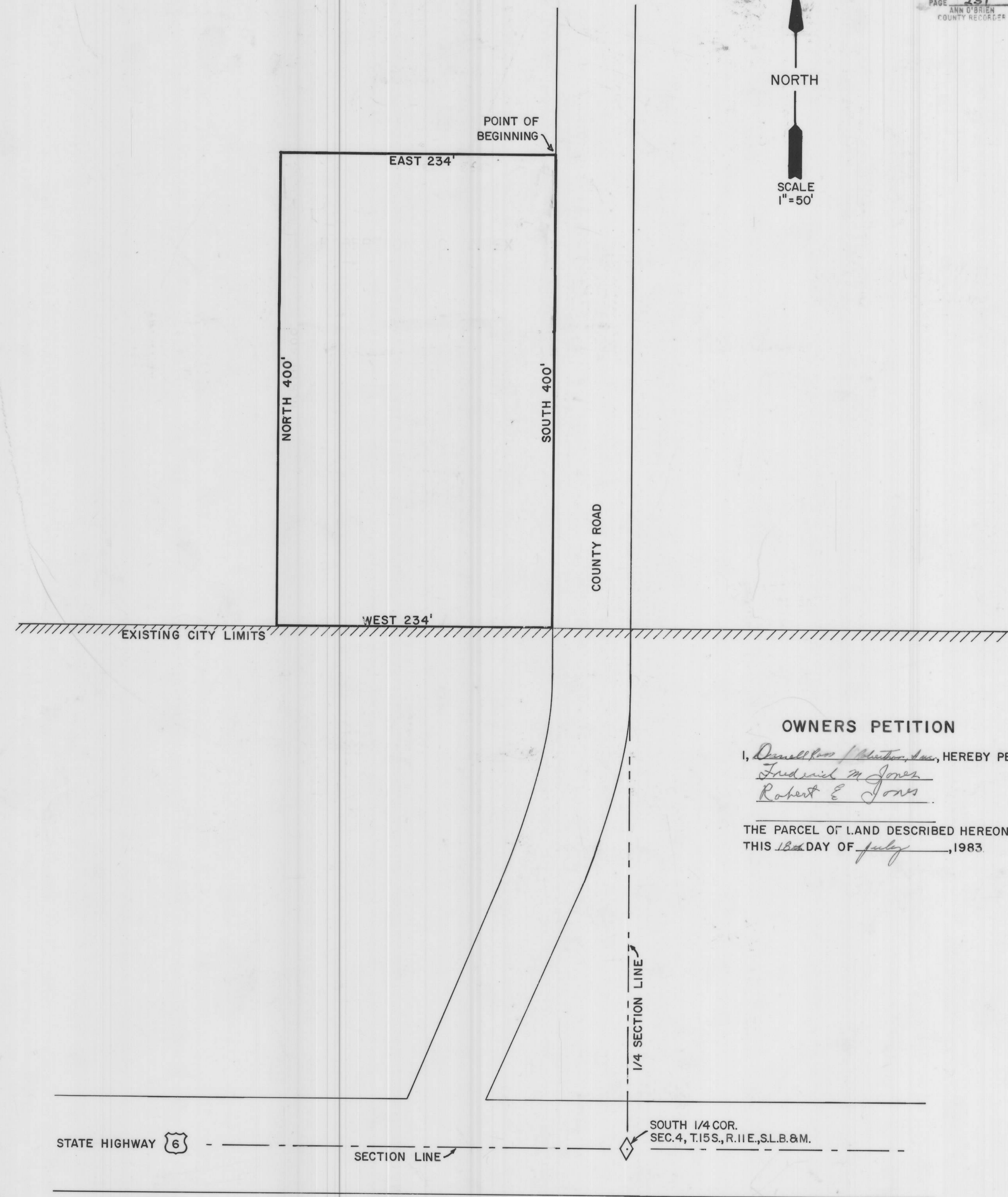

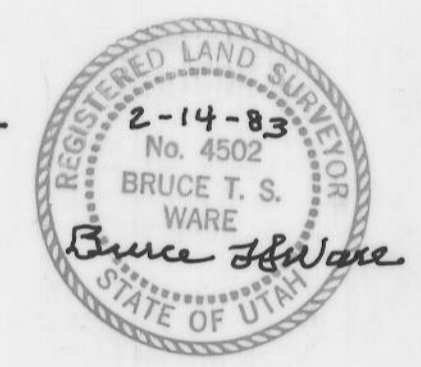

I, BRUCE T.S. WARE, DO HEREBY CERTIFY THAT I AM A REGISTERED LAND SURVEYOR, THAT I HOLD CERTIFICATE NO. 4502 AS PRESCRIBED BY THE LAWS OF THE STATE OF UTAH, THAT THE TRACT OF LAND SHOWN HEREON TO BE ANNEXED IS DESCRIBED AS FOLLOWS:

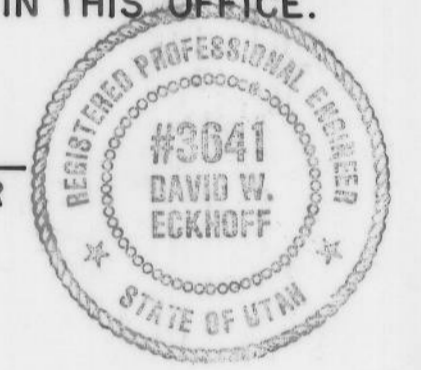

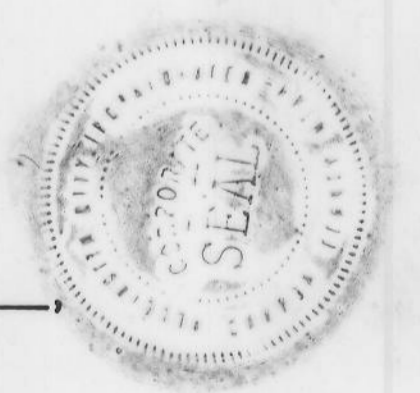
