

BEGINNING AT A POINT 2104.58 FEET SOUTH AND 2738.35 FEET EAST OF THE NORTHWEST CORNER OF SECTION 18, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN, SAID POINT OF BEGINNING IS ON THE EAST RIGHT OF WAY OF THE COUNTY ROAD AND IN THE CENTER OF PINNACLE CREEK, THENCE \$38°04'E 291.75 FEET ALONG THE CENTER OF PINNACLE CREEK, THENCE \$66°04'E 108.37 FEET ALONG THE CENTER OF PINNACLE CREEK, THENCE WEST 319.00 FEET TO THE EAST RIGHT OF WAY OF THE COUNTY ROAD, THENCE N8°27'30"E 275.60 FEET ALONG THE EAST RIGHT OF WAY OF THE COUNTY ROAD TO THE POINT OF BEGINNING.
