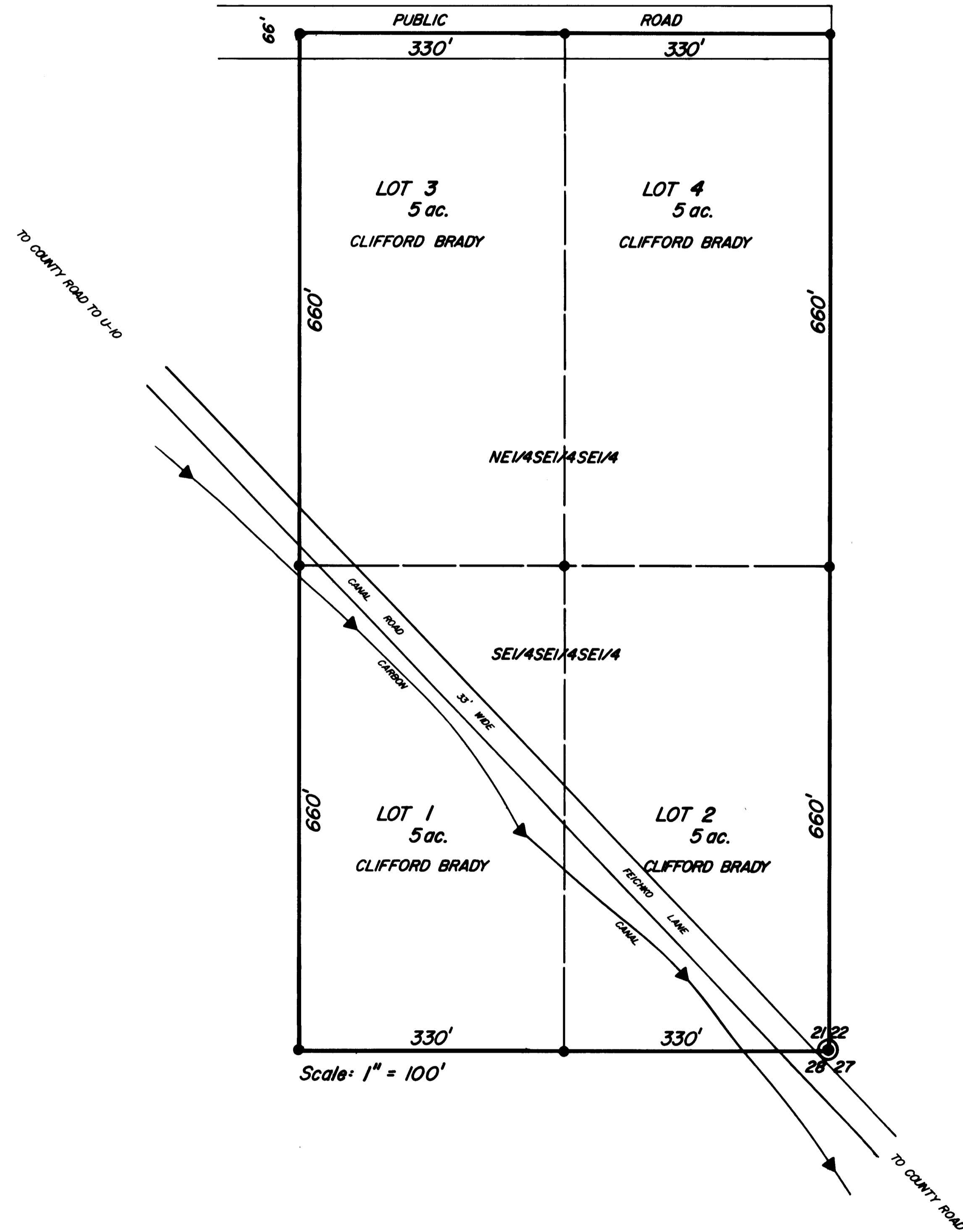

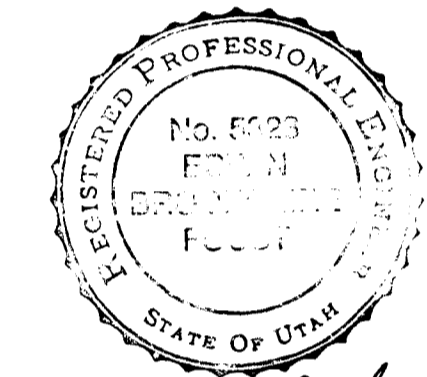

- LOT 2 : BEGINNING AT THE SE CORNER OF SECTION 21, TOWNSHIP 15 SOUTH, RANGE 10 EAST, SLM; THEN NORTH 660'; WEST 330'; SOUTH 660'; THEN EAST 330' TO POINT OF BEGINNING. PARCEL CONTAINS 5 ACRES.
- LOT 3 : BEGINNING AT A POINT 660' NORTH AND 330' WEST OF THE SE CORNER OF SECTION 21, TOWNSHIP 15 SOUTH, RANGE 10 EAST, SLM; THEN NORTH 660'; WEST 330'; SOUTH 660'; THEN EAST 330' TO POINT OF BEGINNING. PARCEL CONTAINS 5 ACRES.
