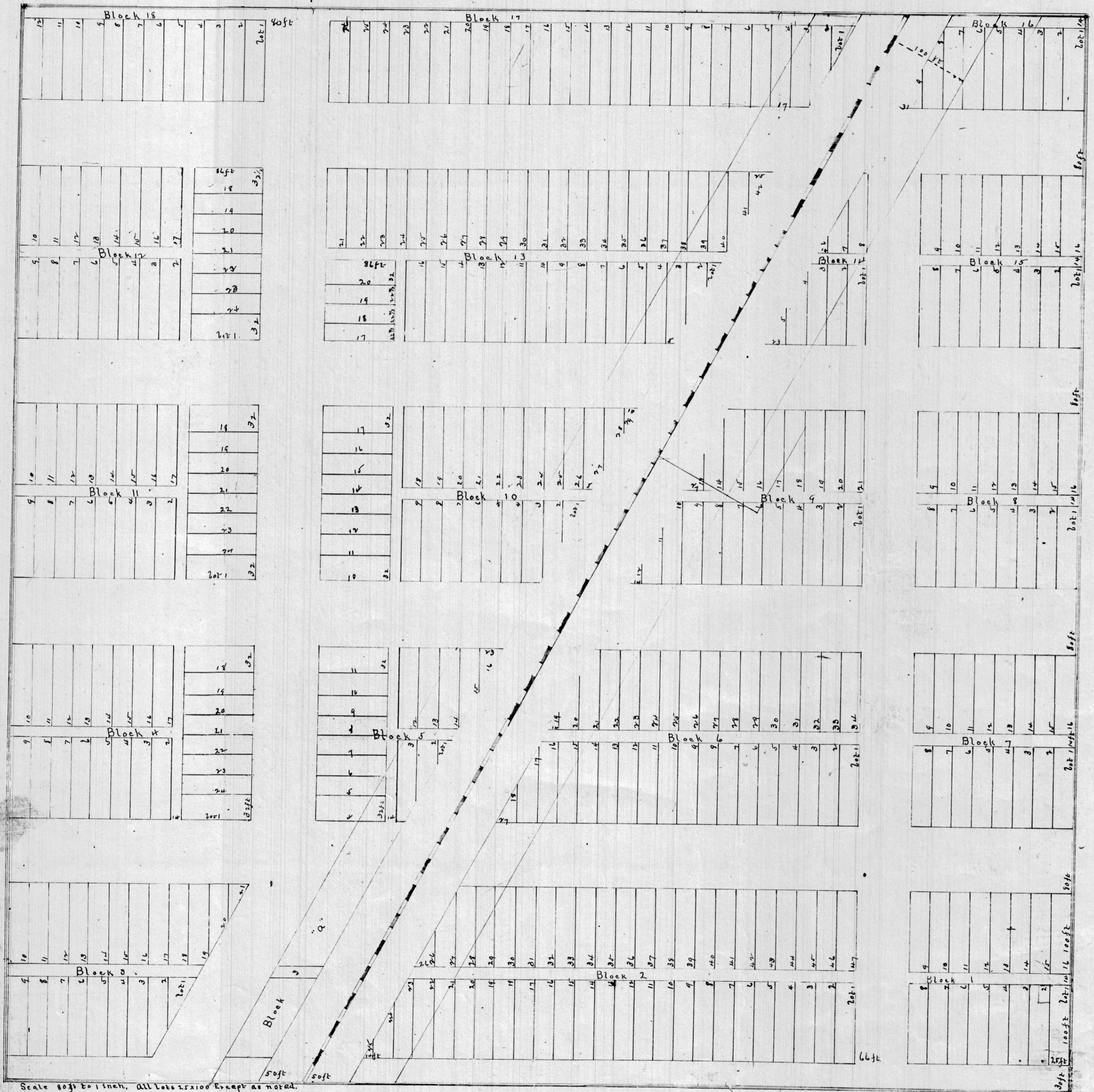


# Helper Town Plat.



HELPER TOWN PLAT.  
 SUBDIVISION OF THE NORTH EAST 1/4 OF THE SOUTHEAST 1/4, SECTION 24, TOWNSHIP  
 13 South, RANGE 9 East of the SALT LAKE MERIDIAN.

**SURVEYORS CERTIFICATE.**  
 I hereby certify that the tract of land shown on this map and owned by \_\_\_\_\_ is bounded and described as follows, to wit: commencing at the Northeast corner of the Northeast quarter of the Southeast quarter of Section twenty four (24) Township thirteen (13) South of Range nine (9) East of the Salt Lake Meridian; thence South eighty (80) rods; thence West eighty (80) rods; thence North eighty (80) rods; thence East eighty (80) rods to the place of beginning, containing forty acres and known as the Northeast quarter of the Southeast quarter of Section (24) in Township and Range aforesaid and that I have by authority of the said owners thereof subdivided the same into Blocks, Lots, Streets and Alleys to be known as Helper Town Plat and that the same had been correctly staked out on the ground as represented hereon. The following are all the names of the Streets designated for public use, County Road and Sadler Street running North and South and Market, Birch, Hasbrouck and Swell Streets running East and West and all alleys as shown on plat.

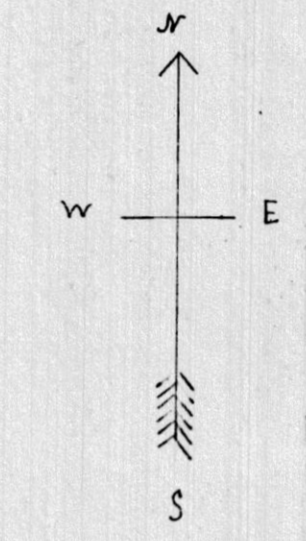
