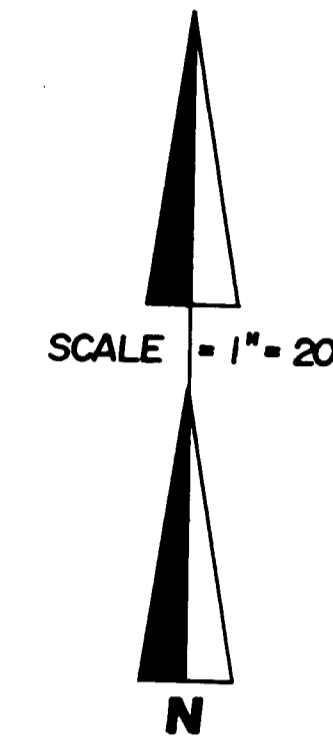
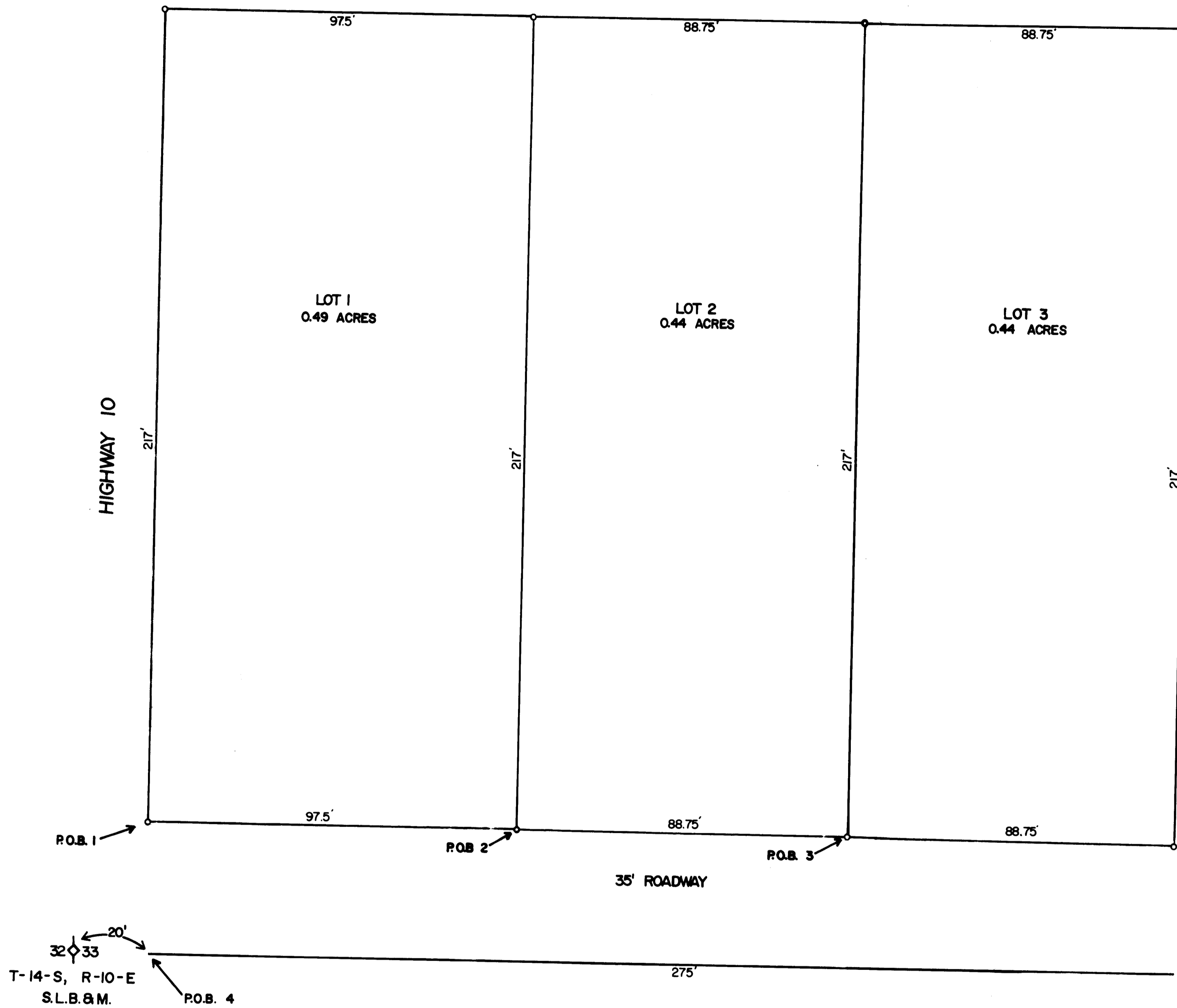

LOT 2
 BEGINNING AT A POINT 117.5 FEET EAST AND 35 FEET NORTH OF THE WEST QUARTER CORNER OF SECTION 33, T-14-S, R-10-E S.L.B.&M., RUNNING THENCE NORTH 217 FEET, THENCE EAST 88.75 FEET, THENCE SOUTH 217 FEET, THENCE WEST 88.75 FEET TO THE POINT OF BEGINNING.

LOT 3
 BEGINNING AT A POINT 206.25 FEET EAST AND 35 FEET NORTH OF THE WEST QUARTER CORNER OF SECTION 33, T-14-S, R-10-E S.L.B.&M., RUNNING THENCE NORTH 217 FEET, THENCE EAST 88.75 FEET, THENCE SOUTH 217 FEET, THENCE WEST 88.75 FEET TO THE POINT OF BEGINNING.
