THE PURPOSE OF THIS SURVEY IS TO LOCATE AND SUBDIVIDE PARCEL 02-1651-0000.

THE BASIS OF BEARING USED FOR THIS SURVEY IS SOUTH 00°32'38" EAST BETWEEN THE EAST QUARTER CORNER AND THE SOUTHEAST CORNER OF SECTION 29, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN.

THE 2002 "LAZY 'S' MINOR SUBDIVISION PLAT" WAS USED AS A REFERENCE IN PREPARING THIS PLAT.

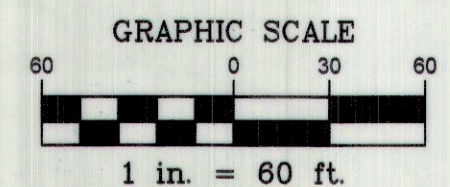
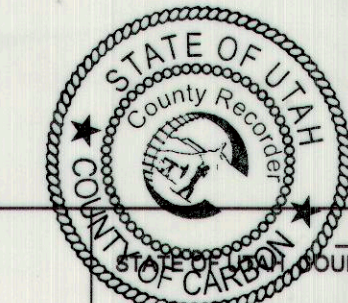


## VICINITY MAP
