

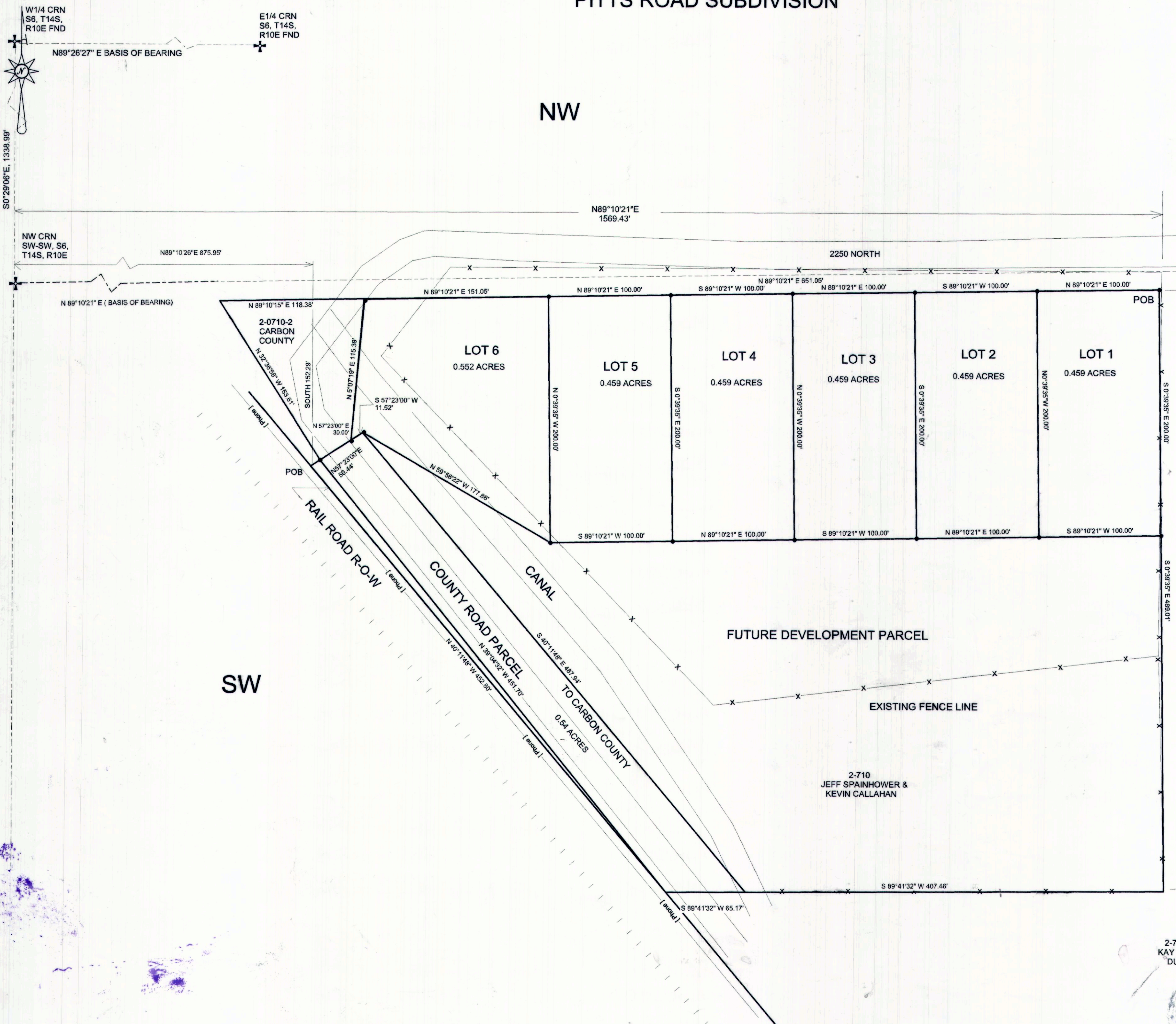
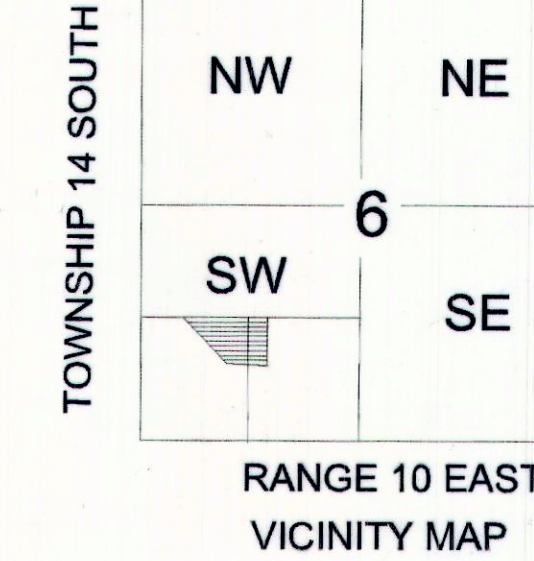
PITTS ROAD SUBDIVISION

LEGAL DESCRIPTION

DESCRIPTION OF A PARCEL OF LAND IN CARBON COUNTY, UTAH WHICH IS LOCATED IN THE SOUTH HALF OF THE SOUTHWEST QUARTER OF SECTION 6, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN DESCRIBED AS FOLLOWS: BEGINNING AT A POINT WHICH LIES NORTH 89°10'21" EAST, 1569.43 FEET, ALONG THE 40 ACRE LINE, AND SOUTH 0°49'39" EAST, 16.50 FEET FROM THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 6, SAID POINT OF BEGINNING IS THE NORTHEAST PROPERTY CORNER OF STACIA A. SOWER TRUST, BRITTANY R. SOWER AND CHRISTOPHER M. SOWER PROPERTY, AND RUNNING SOUTH 0°39'35" EAST, 489.01 FEET, ALONG THE EXISTING FENCE LINE; THENCE SOUTH 89°41'32" WEST, 407.46 FEET MORE OR LESS TO THE D&RG RAILROAD RIGHT OF WAY; THENCE NORTH 39°04'32" WEST, 451.70 FEET; THENCE NORTH 57°23'00" EAST, 30.00 FEET; THENCE NORTH 5°07'19" EAST, 115.39 FEET; THENCE NORTH 89°10'21" EAST, 651.05 FEET TO THE POINT OF BEGINNING. CONTAINING 6.44 ACRES MORE OR LESS. SUBJECT TO RESERVATIONS AND RESTRICTIONS OF RECORD AND RIGHT OF WAYS AND EASEMENTS EVIDENCED. BASIS OF BEARING IS NORTH 89°26'27" EAST BETWEEN THE WEST QUARTER CORNER AND THE EAST QUARTER CORNER OF SAID SECTION 6.

DESCRIPTION OF A PARCEL OF LAND IN CARBON COUNTY, UTAH WHICH IS LOCATED IN THE SOUTHWEST QUARTER OF SECTION 6, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN DESCRIBED AS FOLLOWS: BEGINNING AT A POINT WHICH LIES NORTH 89°10'21" EAST, 875.95 FEET AND SOUTH 152.29 FEET FROM THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 6 AND RUNNING NORTH 57°23'00" EAST, 50.44 FEET; THENCE SOUTH 40°11'48" EAST, 487.94 FEET; THENCE SOUTH 89°41'32" WEST, 65.16 FEET, TO THE EAST RAILROAD RIGHT OF WAY LINE, THENCE NORTH 40°11'48" WEST, 452.80 FEET, ALONG SAID RIGHT OF WAY LINE, THENCE NORTH 57°23'00" EAST, 50.44 FEET TO THE POINT OF BEGINNING. CONTAINING 0.54 ACRES MORE OR LESS.
