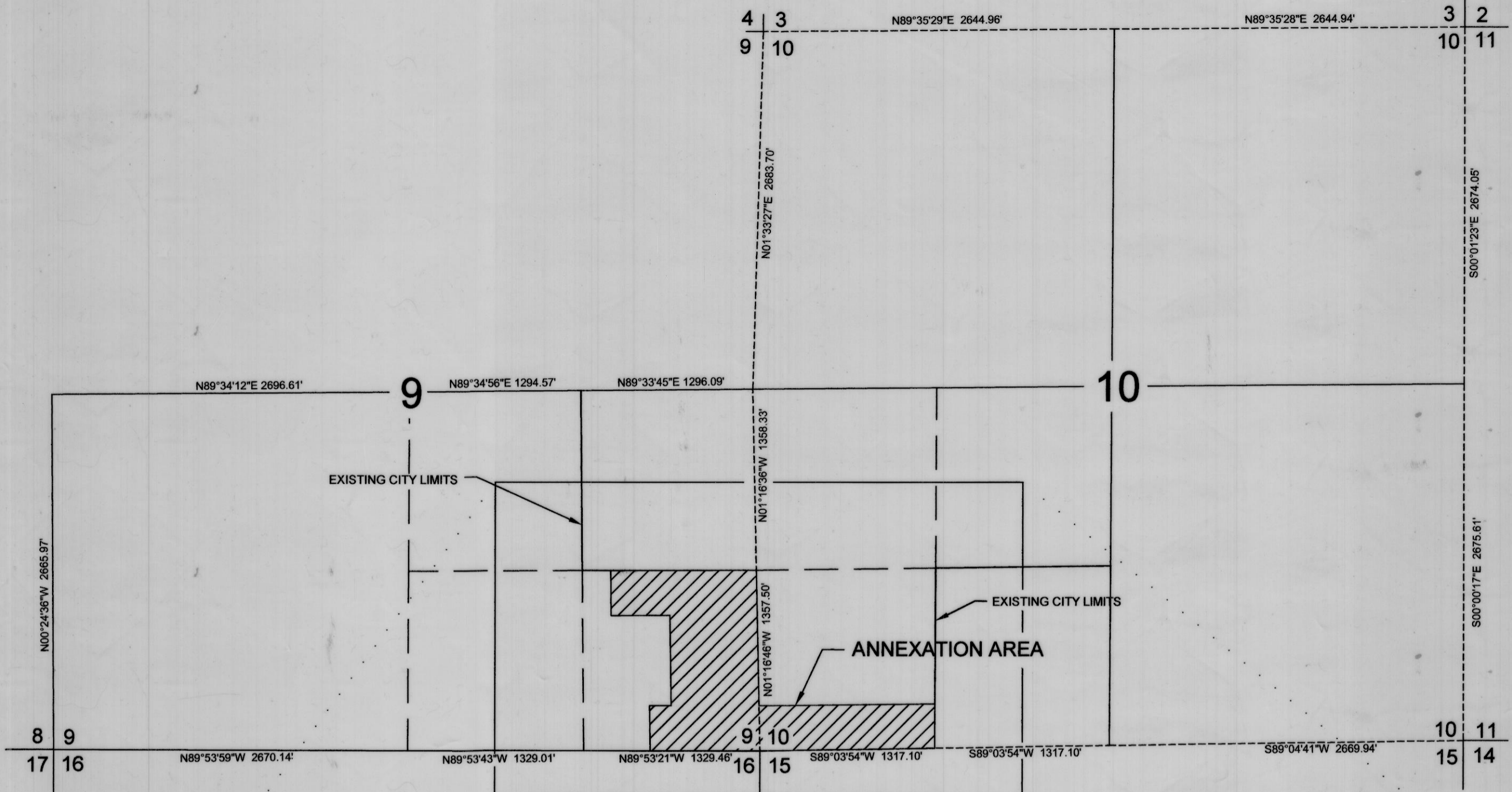


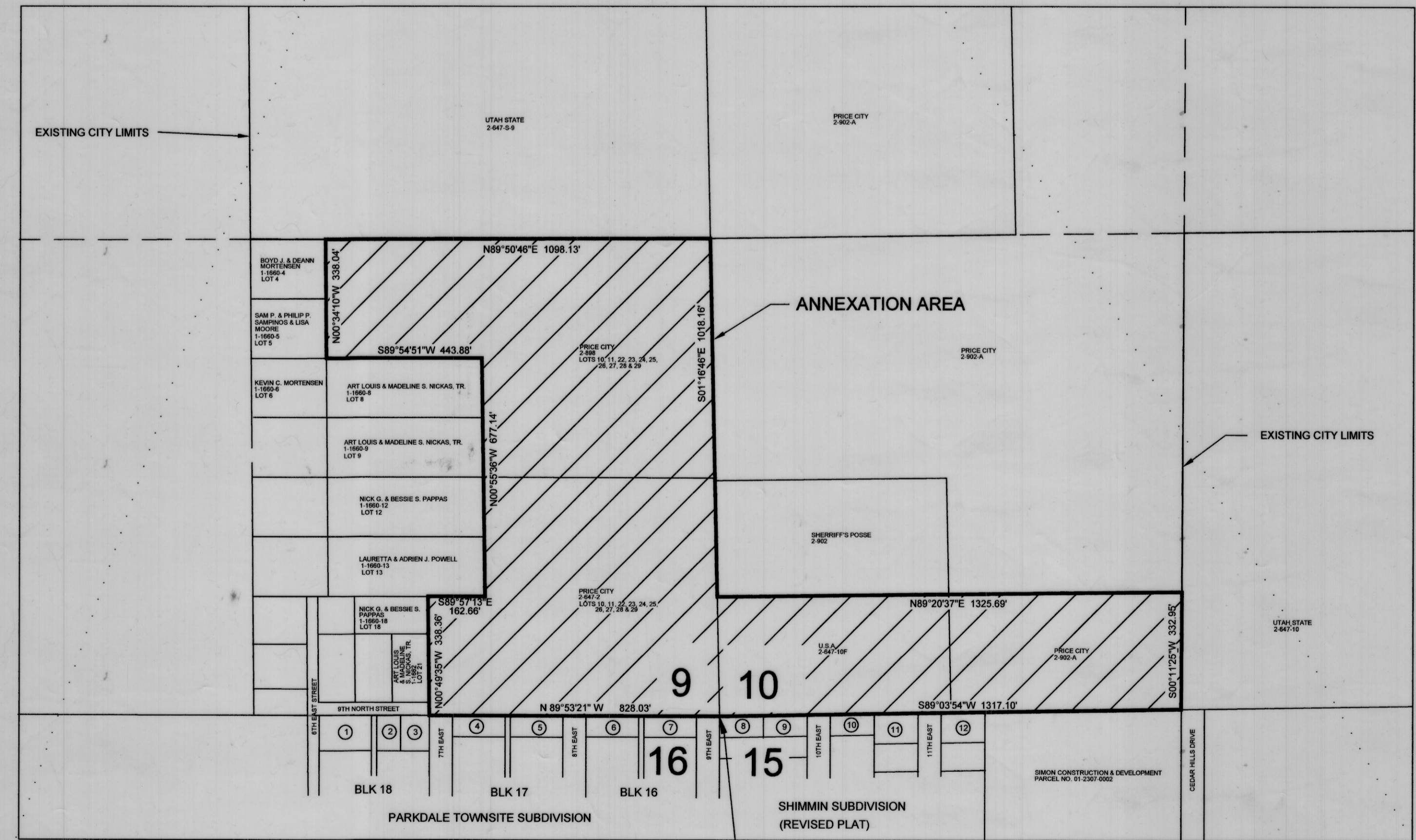

PROPERTY DESCRIPTION

BEGINNING AT THE SOUTHEAST CORNER OF SECTION 9, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE & MERIDIAN AND RUNNING THENCE N89°32'21"W, 828.03' ALONG THE SOUTH LINE OF SAID SECTION 9, WHICH IS THE NORTH LINE OF THE PARKDALE SUBDIVISION, BLOCKS 16 AND 17, THENCE N00°49'36"W 338.36'; THENCE S89°57'13"E 162.66'; THENCE N00°55'36"W 677.14'; THENCE S89°54'51"W 443.88'; THENCE N00°34'10"W 338.04'; THENCE N89°50'46"E 1098.13' TO THE EAST LINE OF SAID SECTION 9, THENCE S01°16'48"E 1018.16'; THENCE N89°20'37"E 1325.69'; THENCE S00°11'25"W 332.95' TO THE SOUTH LINE OF SECTION 10, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE & MERIDIAN, THENCE S89°03'54"W 1317.10' TO THE POINT OF BEGINNING, CONTAINING 35.46 ACRES

NOTES:

- A FIELD SURVEY OF THE ANNEXATION AREA WAS NOT PERFORMED. THE PROPERTY DESCRIPTION WAS DETERMINED FROM THE RECORDS OF THE CARBON COUNTY SURVEYOR'S OFFICE OF THE GENERALLY ACCEPTED UTAH STATE PLANE COORDINATES OF THE STANDARD SECTION CORNERS IN THE AREA.
- PROPERTY PARCEL INFORMATION FROM THE CARBON COUNTY RECORDERS OFFICE WAS USED TO DETERMINE THE PRIVATE AND PUBLIC PROPERTY PARCELS SHOWN ON THIS ANNEXATION PLAT.
- ALL BEARINGS AND DISTANCES ARE FROM CARBON COUNTY RECORDS.
- THE BASIS OF BEARING IS UTAH STATE PLANE GRID NORTH.
- NO PROPERTY CORNERS WERE SET FOR THIS ACTION.
