

KIAHTIPES GRAVEL DESCRIPTION

A PARCEL OF LAND LOCATED IN THE SOUTH ONE-HALF OF SECTION 36, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN WITH A BEARING OF NORTH 89° 14' 47" EAST, 2,664.74 FEET BETWEEN THE SOUTH ONE-QUARTER CORNER AND THE SOUTHEAST CORNER OF SECTION 36, USED AS THE BASIS OF BEARING; BEING FURTHER DESCRIBED AS FOLLOWS, TO-WIT:

BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 36, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN; SAID POINT OF BEGINNING IS ALSO LOCATED N 89° 14' 47" E, I,332.37 FEET AND N 0° 47' 09" W, I,317.26 FEET FROM THE SOUTH QUARTER CORNER OF SAID SECTION 36; AND RUNNING THENCE S 0° 47' 09" E, 430.55 FEET ALONG THE EAST LINE OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 36; THENCE ALONG THE EDGE OF A RIDGE ACCORDING TO THE FOLLOWING PARTICULAR COURSES AND DISTANCES, TO-WIT; THENCE S 71° 16' 43" W, 191.90 FEET; THENCE S 35° 49' 48" W, 153.42 FEET; THENCE N 39° 01' 00" W, 229.54 FEET; THENCE N 3° 41' 15" E, 127.28 FEET; THENCE N 27° 40' 43" W, 238.91 FEET; THENCE S 1° 11' 19" W, 169.71 FEET; THENCE S 38° 27' 03" W, 143.17 FEET; THENCE S 84° 01' 34" W, 122.55 FEET; THENCE N 47° 22' 40" W, 64.22 FEET; THENCE N 6° 59' 33" W, 402.57 FEET LEAVING THE EDGE OF THE RIDGE; THENCE N 19° 19' 24" W, 673.98 FEET; THENCE N 59° 22' 00" E, 497.00 FEET; THENCE S 4° 01' 00" W, 251.60 FEET; THENCE S 21° 19' 00" E, 236.50 FEET; THENCE S 44° 23' 00" E, 267.00 FEET; THENCE S 52° 48' 50" E, 456.80 FEET TO THE POINT OF


KIAHTIPES PROPERTY BELOW GRAVEL PIT

A PARCEL OF LAND LOCATED IN THE SOUTH ONE-HALF OF SECTION 36, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN, AND THE NORTHWEST ONE QUARTER OF THE NORTHEAST ONE QUARTER OF SECTION 1, TOWNSHIP 15 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN, WITH A BEARING OF NORTH 89° 14' 47" EAST, 2,664.74 FEET BETWEEN THE SOUTH ONE QUARTER CORNER AND THE SOUTHEAST CORNER OF SECTION 36, USED AS THE BASIS OF BEARING BEING FURTHER DESCRIBED AS FOLLOWS, TO-WIT;

BEGINNING AT A POINT ON THE EAST LINE OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 36, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN, WHICH POINT IS LOCATED S 0° 47' 09" E, 430.55 FEET FROM THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 36; SAID POINT IS ALSO LOCATED N 89° 14' 47" E, 1,332.37 FEET AND N 0° 47' 09" W, 886.71 FEET FROM THE SOUTH QUARTER CORNER OF SAID SECTION 36; AND RUNNING THENCE S 0° 47' 09" E, 886.71 FEET TO THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 36; SAID POINT IS ALSO OF THE SOUTHEAST QUARTER OF SAID SECTION 1, TOWNSHIP 15 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN; THENCE S 0° 30' 33" E, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN; THENCE S 20° 30' 33" E, 332.99 FEET; THENCE S 89° 18' 44" W, 218.66 FEET; THENCE N 22° 49' 41" W, 1365.60 FEET; THENCE N 84° 01' 34" E, 122.55 FEET; THENCE N 38° 27' 03" E, 143.17 FEET; THENCE N 1° 11' 19" E, 169.71 FEET; THENCE S 27° 40' 43" E, 238.91 FEET; THENCE S 3° 41' 15" W, 127.28' FEET; THENCE S 39° 01' 00" E, 229.54 FEET; THENCE N 35° 49' 48" E, 153.42 FEET; THENCE N 71° 16' 43" E, 191.90 FEET TO THE POINT OF BEGINNING.
