BEGINNING AT A POINT SOUTH 1817.78 FEET AND EAST 1323.38 FEET FROM THE WEST QUARTER CORNER OF SECTION 17, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN; SAID POINT BEING ON THE WESTERLY RIGHT OF WAY LINE OF A FREEWAY; RUNNING THENCE SOUTH 82°23'41" WEST, 29.53 FEET; THENCE NORTHERLY 145.65 FEET ALONG THE ARC OF A 388.00 FOOT RADIUS CURVE TO THE LEFT (NOTE: CHORD BEARS NORTH 18°11'37" WEST, 144.80 FEET); THENCE NORTH 61°03'08" EAST, 3.74 FEET; THENCE SOUTH 27°43'02" EAST, 153.12 FEET TO THE POINT OF BEGINNING.

CONTAINS 0.375 ACRES, MORE OR LESS.
