

BOUNDARY SURVEY: OF TWO PARCELS IN THE NORTHEAST QUARTER OF SECTION 5, T. 13 S., R. 7 E., S.L.B. & M., IN THE TOWN OF SCOFIELD, CARBON COUNTY, UTAH.

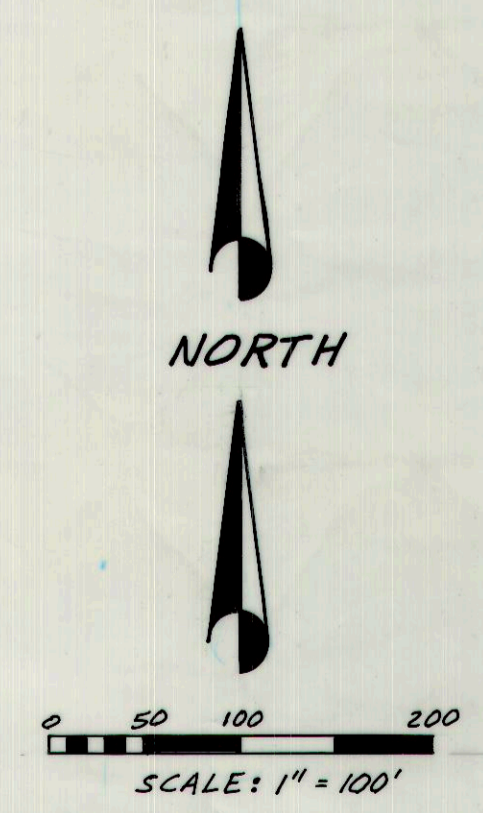
NARRATIVE:
 1. THE PURPOSE OF THIS SURVEY IS TO DETERMINE THE AREA OF SAID PARCELS, LESS HIGHWAY RIGHT OF WAY.
 2. THE BASIS OF ESTABLISHED LINES OF SAID PARCELS ARE AS PER DESCRIPTIONS BK 2, P. 107 & BK. 5, P. 200; CARBON COUNTY RECORDS. FURTHER BEARINGS AND TIES WERE FROM SCOFIELD TOWNSITE PLAT, BK. 2 OF PLATS P 10; CARBON COUNTY RECORDS.
 3. THE CONTROLLING DEED ELEMENTS ARE ON MAP AT LEFT NOTED BK. & P., OR AS NON-PARENTHESED BRG. & DIST. FOUND MONUMENTS ARE DENOTED (FND) OR BY O.

DESCRIPTION: PARCEL 1
 BASED ON THE UTAH STATE PLANE COORDINATE SYSTEM (GROUND DISTANCES USED), BEGINNING AT A POINT WHICH IS SOUTH 156.66 AND WEST 1797.08 FEET FROM THE NORTHEAST CORNER OF SECTION 5, T. 13 S., R. 7 E., S.L.B. & M., SAID POINT BEING THE INTERSECTION OF THE N. LINE OF MARKET STREET (PROJECTED) AND THE EAST R/W LINE OF STATE ROAD 96; THENCE S 76° 04' 18" E, 63.28 FT. MORE OR LESS TO THE WEST LINE OF BLOCK 23, SCOFIELD TOWNSITE; THENCE S 21° 34' 37" W, 1167.12 FT. TO A POINT ON THE S. LINE OF LOT 2, SEC. 5; THENCE S 89° 45' 42" W, ALONG SAID LINE, 6.97 FT. TO THE EAST R/W LINE OF STATE ROAD 96; THENCE N 17° 59' 08" E, ALONG SAID R/W LINE, 805.26 FT.; THENCE N 60° 04' 48" W, ALONG SAID R/W LINE, 8.00 FT.; THENCE N 21° 55' 42" E, ALONG SAID R/W LINE, 357.57 FT. TO THE POINT OF BEGINNING; CONTAINS 1.10 ACRES MORE OR LESS.

PARCEL 2
 BASED ON THE UTAH STATE PLANE COORDINATE SYSTEM (GROUND DISTANCES USED), BEGINNING AT A POINT WHICH IS SOUTH 680.72 FEET AND WEST 2049.45 FEET FROM THE NORTHEAST CORNER OF SECTION 5, T. 13 S., R. 7 E., S.L.B. & M., SAID POINT BEING ON THE WEST R/W LINE OF STATE ROAD 96; THENCE S 17° 59' 08" W, 939.24 FT.; THENCE N 72° 23' 42" W 28.44 FT.; THENCE N 17° 15' 42" E 154.00 FT. TO A POINT ON A CURVE TO THE LEFT; THENCE ALONG SAID CURVE (CURVE HAS A RADIUS OF 576.02 FT., CHORD BEARS N 3° 25' 00" E, 160.00 FT) THROUGH A CENTRAL ANGLE OF 15° 58' 00" A DISTANCE OF 160.52 FT. TO A POINT ON THE S. LINE OF LOT 2, SEC. 5; THENCE S 89° 45' 42" W, ALONG SAID LINE, 12.93 FT.; THENCE NORTHWESTERLY ON A CURVE TO THE LEFT (CURVE HAS A RADIUS OF 221.90 FT., CHORD BEARS N 58° 22' 29" W, 352.12 FT.) THROUGH A CENTRAL ANGLE OF 105° 00' 45" A DISTANCE OF 406.70 FT., TO A POINT ON THE WEST LINE OF LOT 2, SEC. 5; THENCE N 0° 44' 58" W, ALONG SAID LINE, 63.00 FT.; THENCE N 70° 55' 42" E, 181.70 FT. TO AN EXISTING FENCE CORNER; THENCE N 2° 34' 42" E, 10.00 FT.; THENCE N 71° 05' 42" E, 20.60 FT., TO A POINT ON A CURVE TO THE LEFT; THENCE ALONG SAID CURVE (CURVE HAS A RADIUS OF 815.90 FT., CHORD BEARS N 56° 27' 44" E, 460.37 FT.) THROUGH A CENTRAL ANGLE OF 32° 26' 43" A DISTANCE OF 462.03 FT. TO THE POINT OF BEGINNING; CONTAINS 2.90 ACRES MORE OR LESS.
