Parcel #1

Beginning at a point 873.2 feet South and 596.3 feet West of the Northeast Corner of the Northeast Quarter of the Southeast Quarter of Section 25, Township 13 South, Range 9 East of the Salt Lake Base & Meridian, said point being situated on the West right—of—way line of County Road; thence South 14.56' West along said right—of—way line 120.8 feet; thence North 68' West 150 feet; thence North 18.07' East 80.5 feet; thence South 83.42' East 146 feet, more or less to the point of beginning.

Parcel #2

Beginning at a point 1886 feet North and 553 feet West of the Southeast Corner of Section 25, Township 13 South, Range 9 East of the Salt Lake Base & Meridian; running thence North 78'30' West 260 feet; thence South 120 feet; thence South 74'50'38" East 100 feet, more or less; thence South 83'42' East 146 feet; thence Northeasterly 100 feet, along the existing county road to the point of beginning.

Said point being on the Easterly right—of—way line of a County Road.
Thence North 68°10'32" West 150.70 feet; thence North 17°46'05" East 9.67 feet; thence South 68°26'27" East 150.36 feet to a point on said right of way line thence along said line South 16°11'34" West 10.39 feet to the point of beginning. Containing 1.504 sq-ft
