NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO DETERMINE THE ACTUAL BOUNDARY OF THE GONZOLAS' PROPERTY. SAID PROPERTY IS SHOWN ON THE LEFT AND DESCRIBED BELOW.

THE BASIS FOR THE ESTABLISHMENT OF SAID BOUNDARY WAS: #1. THE DESCRIPTION OF SAID PROPERTY CONTAINED WITHIN THE REAL ESTATE CONTRACT BETWEEN THE PARTIES LISTED ON THE PLAT AND PETE FRANDSEN.

#2 THE DESCRIPTION OF DUANE FRANDSEN'S PROPERTY CONTAINED IN BOOK #152 ON PAGE #95 AT THE CARBON COUNTY HALL OF RECORDS. SAID PROPERTY BORDERS THE GONZOLAS' PARCEL ON THE EASTERLY SIDE.

#3 THE DESCRIPTION OF PETE FRANDSEN'S PROPERTY CONTAINED IN BOOK #281 ON PAGE #571 AT THE CARBON COUNTY HALL OF RECORDS. SAID PROPERTY BORDERS THE GONZALAS' PARCEL ON THE NORTHWESTERLY SIDE.


