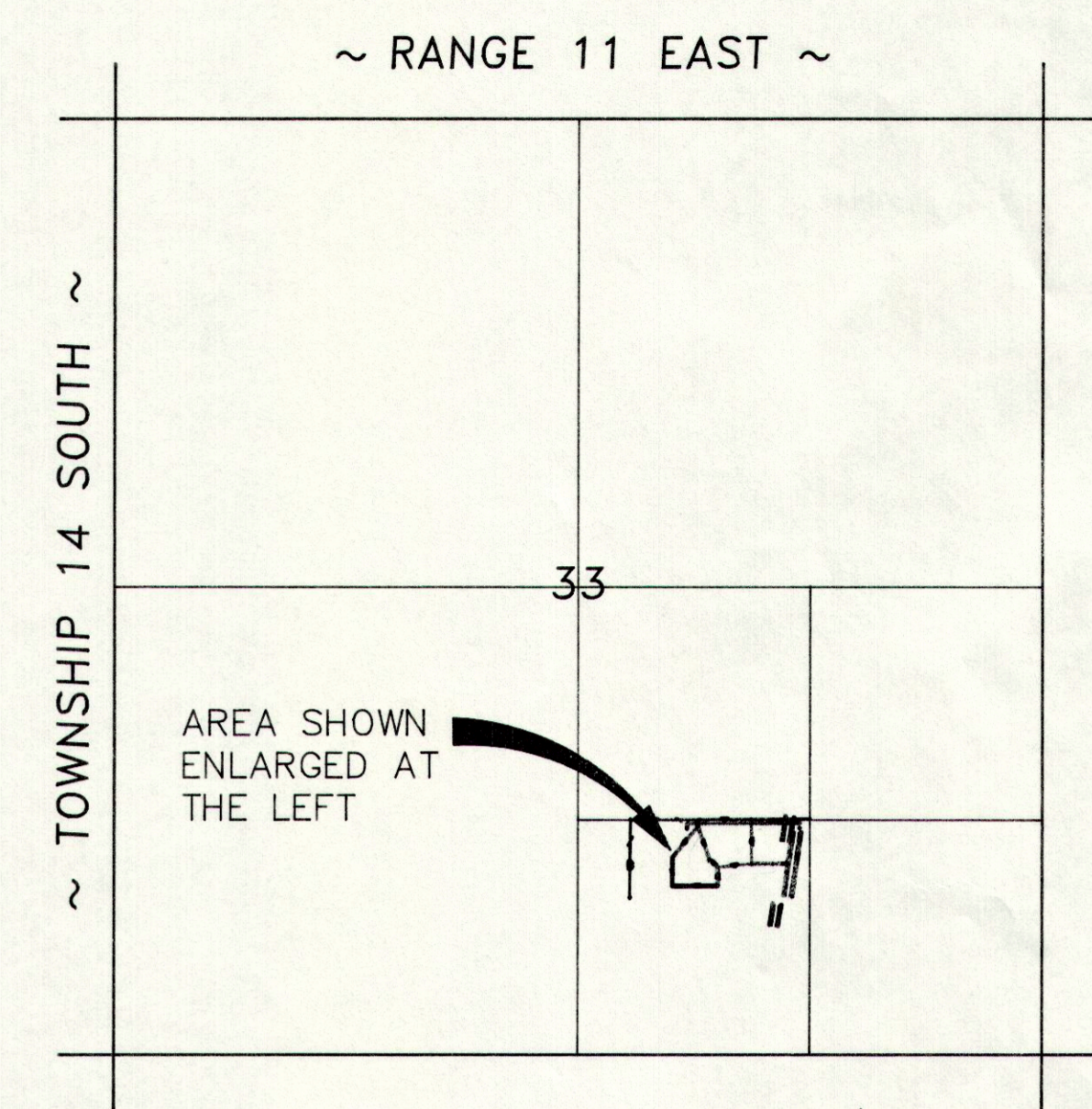
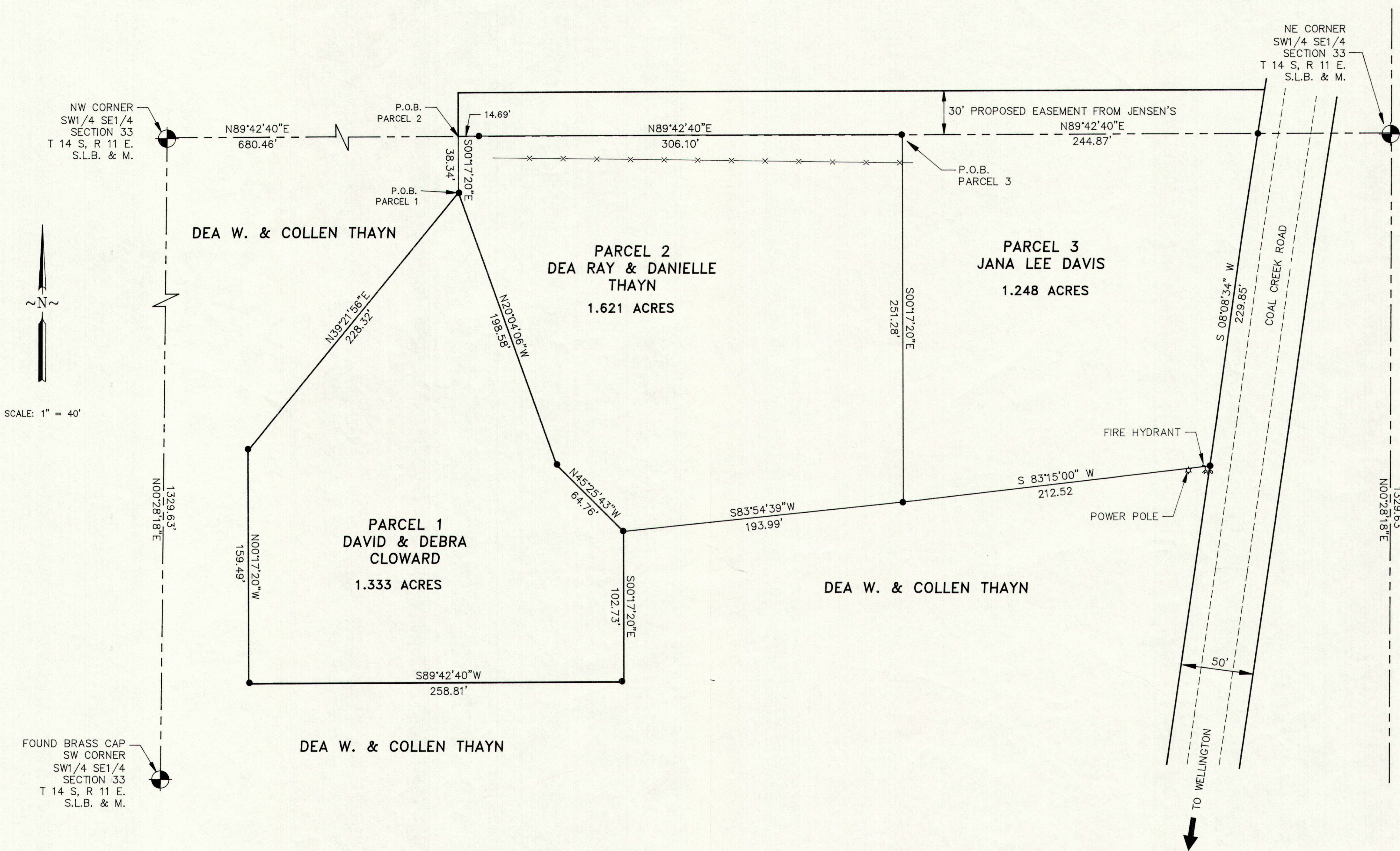


PORTION OF THE SW 1/4 OF THE SE 1/4

A PARCEL OF LAND LOCATED IN CARBON COUNTY, STATE OF UTAH, WHICH IS IN THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 33, TOWNSHIP 14 SOUTH, RANGE 11 EAST, SALT LAKE BASE AND MERIDIAN, BEING FURTHER DESCRIBED AS FOLLOWS WITH A BEARING OF NORTH 89°50'08" EAST BETWEEN THE SOUTH QUARTER CORNER AND THE SOUTHEAST CORNER OF SAID SECTION 33, USED AS THE BASIS OF BEARING.

BEGINNING AT A POINT WHICH IS LOCATED NORTH 0°28'18" EAST, 1329.63 FEET TO THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 33, TOWNSHIP 14 SOUTH, RANGE 11 EAST, SALT LAKE BASE AND MERIDIAN, AND RUNNING THENCE NORTH 89°42'40" EAST ALONG THE NORTH LINE OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER, 680.46 FEET AND SOUTH 0°17'20" EAST, 38.34 FEET FROM THE SOUTH QUARTER CORNER OF SECTION 33, (WHICH IS A BRASS CAP) TOWNSHIP 14 SOUTH, RANGE 11 EAST, SALT LAKE BASE AND MERIDIAN, (SAID POINT OF BEGINNING IS A REBAR WITH A CAP ON THE SOUTH SIDE OF AN EXISTING POWER POLE); AND RUNNING THENCE SOUTH 20°04'06" EAST, 198.58 FEET; THENCE SOUTH 45°25'43" EAST, 64.76 FEET; THENCE SOUTH 0°17'20" EAST, 102.73 FEET; THENCE SOUTH 89°42'40" WEST, 258.81 FEET; THENCE NORTH 0°17'20" WEST, 159.49 FEET; THENCE NORTH 39°21'56" EAST, 228.32 FEET TO THE POINT OF BEGINNING.
