

## NARRATIVE

THE PURPOSE OF THIS SURVEY WAS: (A) TO DETERMINE THE LOCATION OF THE HERZOG PARCEL DESCRIBED IN BOOK #24 PAGE #375 AT THE CARBON COUNTY RECORDER'S OFFICE. SAID DESCRIPTION IS REPRESENTED BY A DASHED BORDER ON THE PLAT AT LEFT AND COPIED BELOW. (B) TO TRANSLATE SAID DESCRIPTION USING 1982 DATUM OF THE UTAH STATE PLANE COORDINATE SYSTEM, AND DETERMINE IT'S LOCATION ON THE GROUND IN RELATION TO SURROUNDING PROPERTIES AND EXISTING IMPROVEMENTS. THE RESULTING LOCATION IS REPRESENTED ON THE PLAT AT THE LEFT BY THE SOLID BORDER, AND IS DESCRIBED BELOW. (C) TO DIVIDE SAID PROPERTY INTO PARCEL "A" AND PARCEL "B" WHICH ARE ALSO DESCRIBED BELOW.


