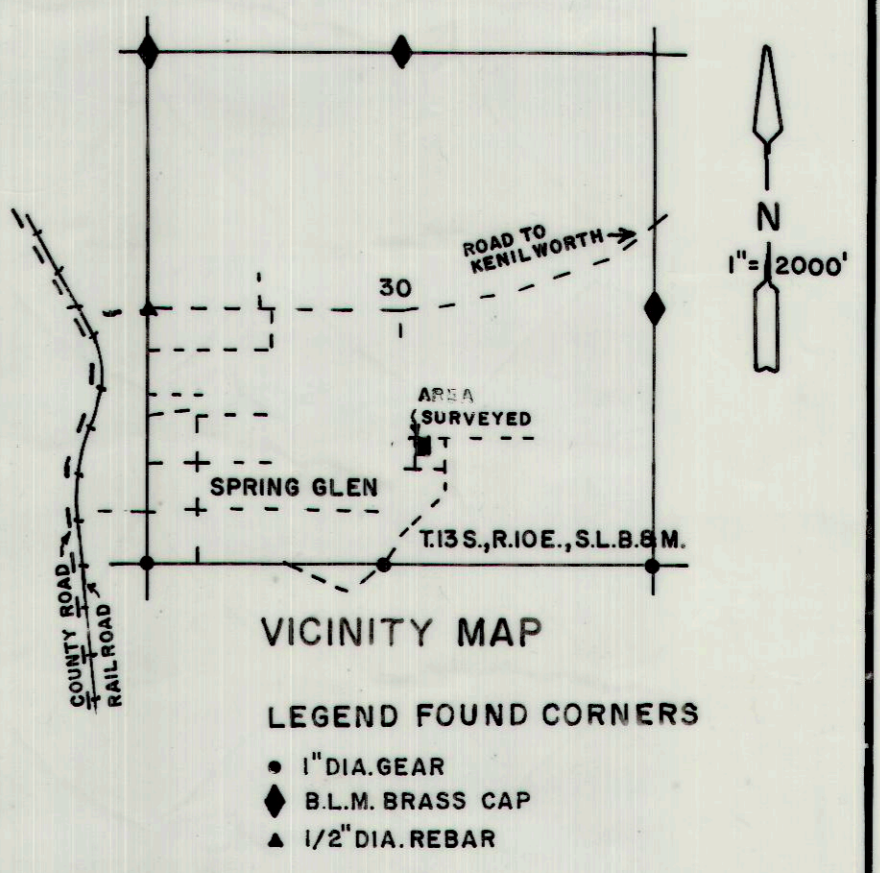


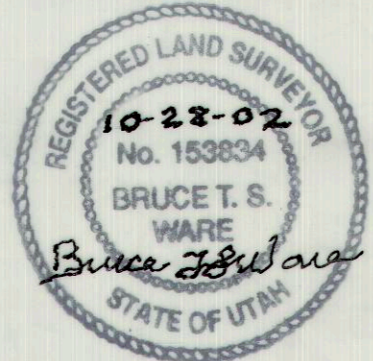

PROPERTY DESCRIPTION
 BEGINNING AT A POINT 321.5 FEET EAST AND 212 FEET SOUTH OF THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 30, TOWNSHIP 13 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN, AND RUNNING THENCE WEST 145 FEET, THENCE NORTH 190 FEET, THENCE EAST 145 FEET, THENCE SOUTH 190 FEET TO THE POINT OF BEGINNING.

NOTE
 THE CALCULATED LOCATION FOR THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 30 DOES NOT MATCH AN EXISTING FENCE CORNER BY 10.8 FEET NORTH AND SOUTH, EAST AND WEST DOES MATCH. THE EXISTING FENCE CORNER FITS OTHER FENCES IN THE AREA AND WAS USED FOR THIS SURVEY.
