

Fence Line Agreement


Both of these sign Agreements are on fill in Sunnyside, City Hall, Utah.

Land Purchase From Sunnyside City

A parcel of land located in Carbon County, State of Utah, which is in the Southeast Quarter of the Northeast Quarter of Section 6, Township 15 South, Range 14 East, Salt lake Base and Meridian, being further described with a bearing of North 85°22' 26" East, between the control monument number 20 and monument number 19 recorded in Sunnyside Remonumentation Subdivision Plat "B" recorded in Carbon County Recorders Office Book 4 Page 270, more particularly described as follows;

Beginning at a point which is located North 50° 25' 46" East, 102.27 feet to a Mag. Nail and North 0° 26' 13" East, 101.77 feet along a agreed fence line, to a agreed fence corner, between DeGiulio of lot 13 and Manley of lot 12; and running thence North 0°26'13" East, 45.33 feet to a rebar; thence South 76°18'17" East, 71.88 feet to a rebar, thence South 5°13' 46" West, 38.93 to an agreed fence corner between Howell of lot 11 and of Manley of lot 12, thence North 81°04' 49" West, 67.45 feet to the Point of Beginning.

Contains 0.066 acres or 2896 square feet more or less.

Narrative

The purpuse of this survey is to stake on the ground the agreed existing fence lines of Lot #12, Block 7A, Sunnyside Subdivision - Plat "B" - Locate in the Southeast quarter of the Northeast quarter of Section 6, Township 15 South Range 14 East, Salt Lake Base and Meridian; and to measure the lines to points that Gerry Mannley set and Sunnyside City agreed too, which are extented exsiting fence lines northerly from rear of said Lot #12, on to the land to be purchase from Sunnyside City.

Dragerton Townsite Subdivision Moument

Basis of bearing is from the recorded Sunnyside Remonumentation Subdivision Plat "B" Book 4 of Plats Page 270 March 22, 1988. Moumements used where set in the sidewalks control monument no. 20 (which remains is a brass X) and the back sight is brass control monument no.19, which undisturbed.
