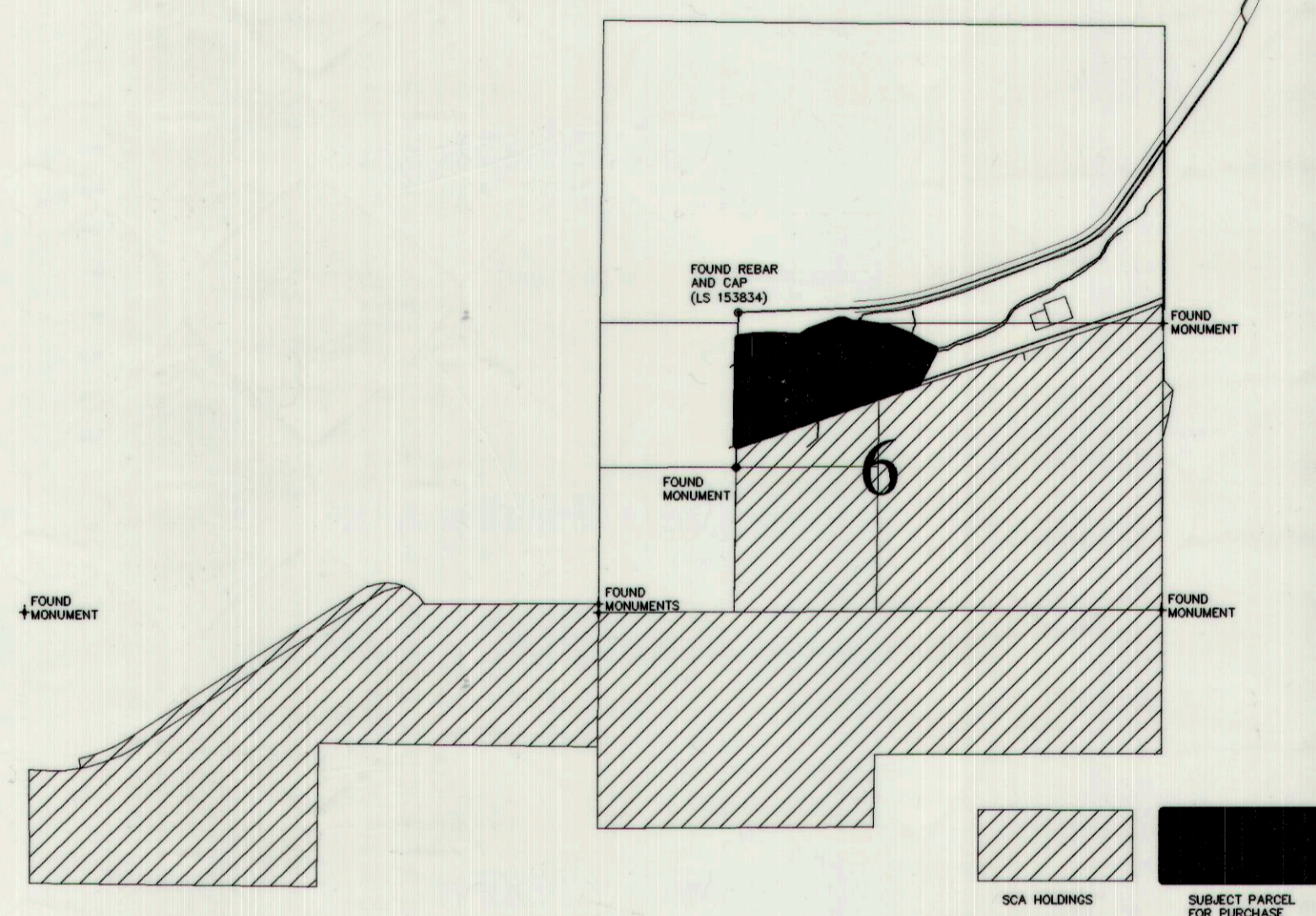

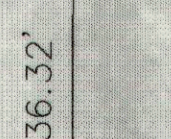


NORTHEAST CORNER

 SLB&M

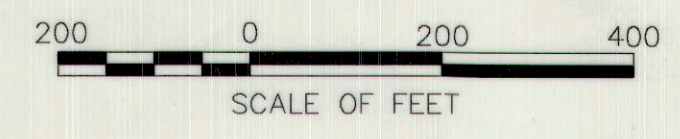


BASIS OF BEARING

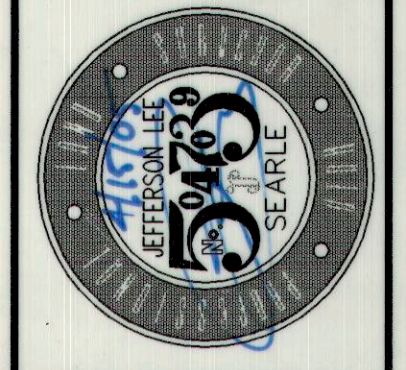
