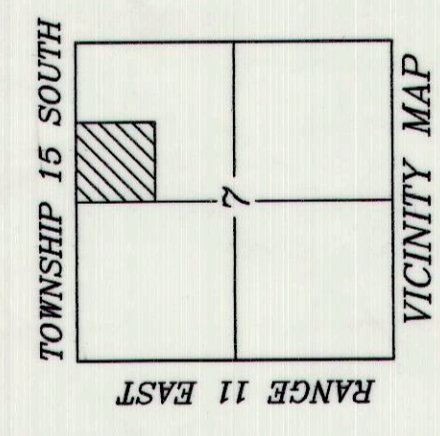

**DESCRIPTION**

BEGINNING AT A POINT 386 FEET SOUTH AND 365.31 FEET WEST FROM THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 7 TOWNSHIP 15 SOUTH RANGE 11 EAST OF THE SALT LAKE BASE AND MERIDIAN;  
COUNT BEING ON THE WESTERLY RIGHT OF WAY LINE OF A CITY STREET, THENCE WEST 117 FEET; THENCE NORTH 36 FEET; THENCE WEST 300 FEET; THENCE SOUTH 590.80 FEET TO THE NORTHERLY RAIL ROAD LINE; THENCE ALONG SAID LINE S71°37'21"E 473.84 FEET; THENCE NORTH 157.70 FEET; THENCE WEST 30.0 FEET; THENCE NORTH 552.08 FEET TO THE POINT OF BEGINNING.

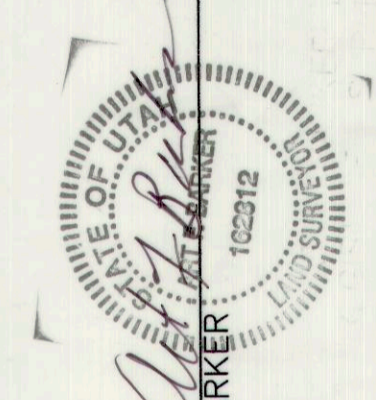

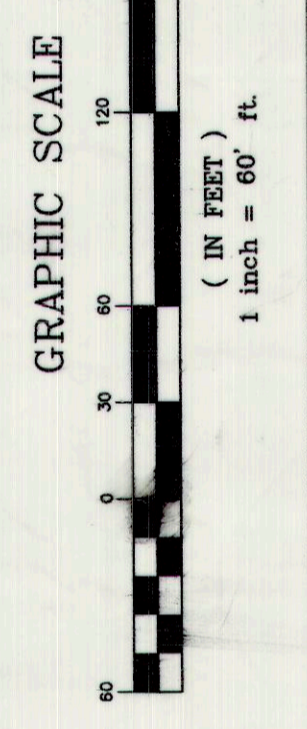

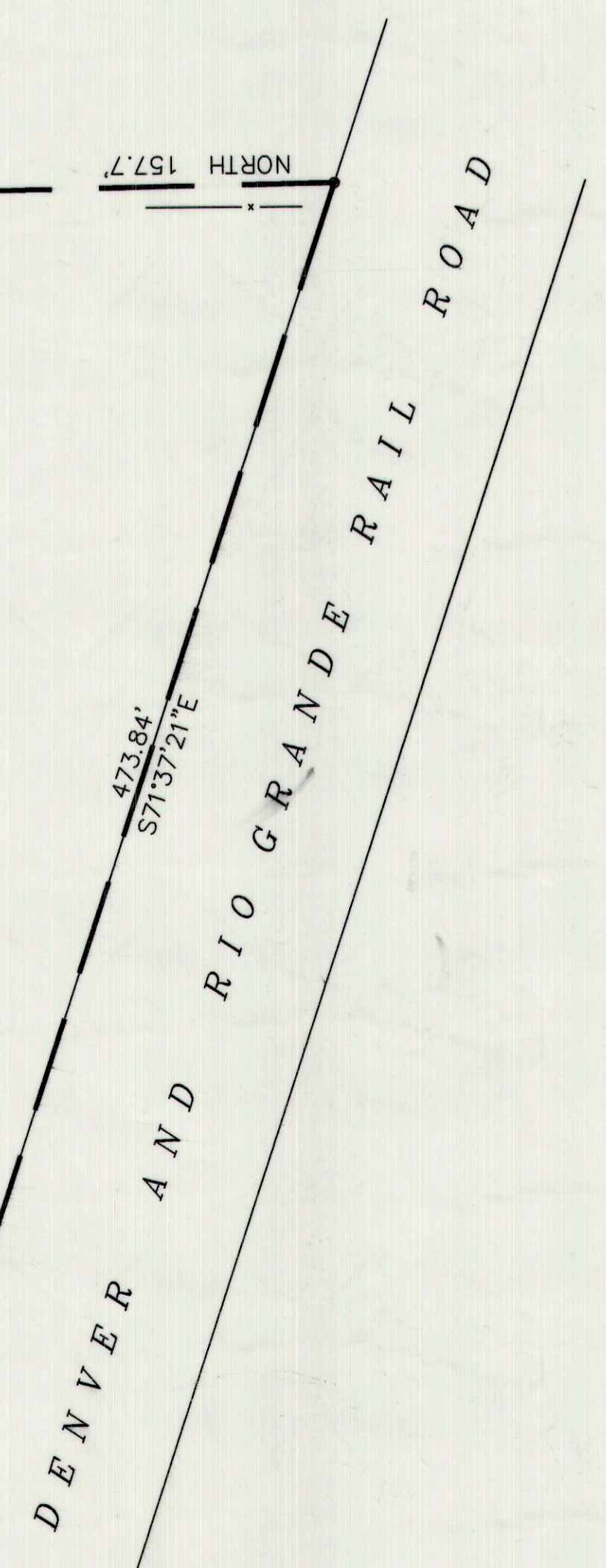
