NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO LOCATE ON THE GROUND AND DESCRIBE A PARCEL OF LAND BEING PART OF THE LAND DESCRIBED IN BOOK 581 AT PAGES 144 AND 145 OF THE PUBLIC RECORDS OF THE COUNTY OF GARFIELD, UTAH. THE BASIS OF BEARING FOR THE SURVEY IS S89°13'14"E BETWEEN THE SOUTH EAST CORNER AND THE SOUTH QUARTER CORNER OF SECTION 5 T-15-S R-11-E OF THE SALT LAKE BASE AND MERIDIAN, HAVING A DISTANCE OF 2670.24 FEET.

DESCRIPTION

BEGINNING AT A POINT S89°13'14"E 1990.56 FEET ALONG THE SECTION LINE AND NORTH 35.43 FEET FROM THE SOUTHEAST CORNER OF SECTION 5 TOWNSHIP 15 SOUTH RANGE 11 EAST OF THE SALT LAKE BASE AND MERIDIAN POINT BEING ON THE NORTHERLY LINE OF HIGHWAY 50 & 6, THENCE N00°30'25"W ALONG AN EXISTING FENCE LINE 144.0 FEET; THENCE ALONG SAID FENCE LINE S89°11'23"W 160.0 FEET TO THE EASTERLY LINE OF 1285 EAST STREET, THENCE ALONG SAID LINE S00°22'08"E 144.0 FEET TO SAID NORTHERLY LINE, THENCE ALONG SAID LINE N89°11'23"E 160.0 FEET TO THE POINT OF BEGINNING, CONTAINING 2.3040 SQ. FEET.

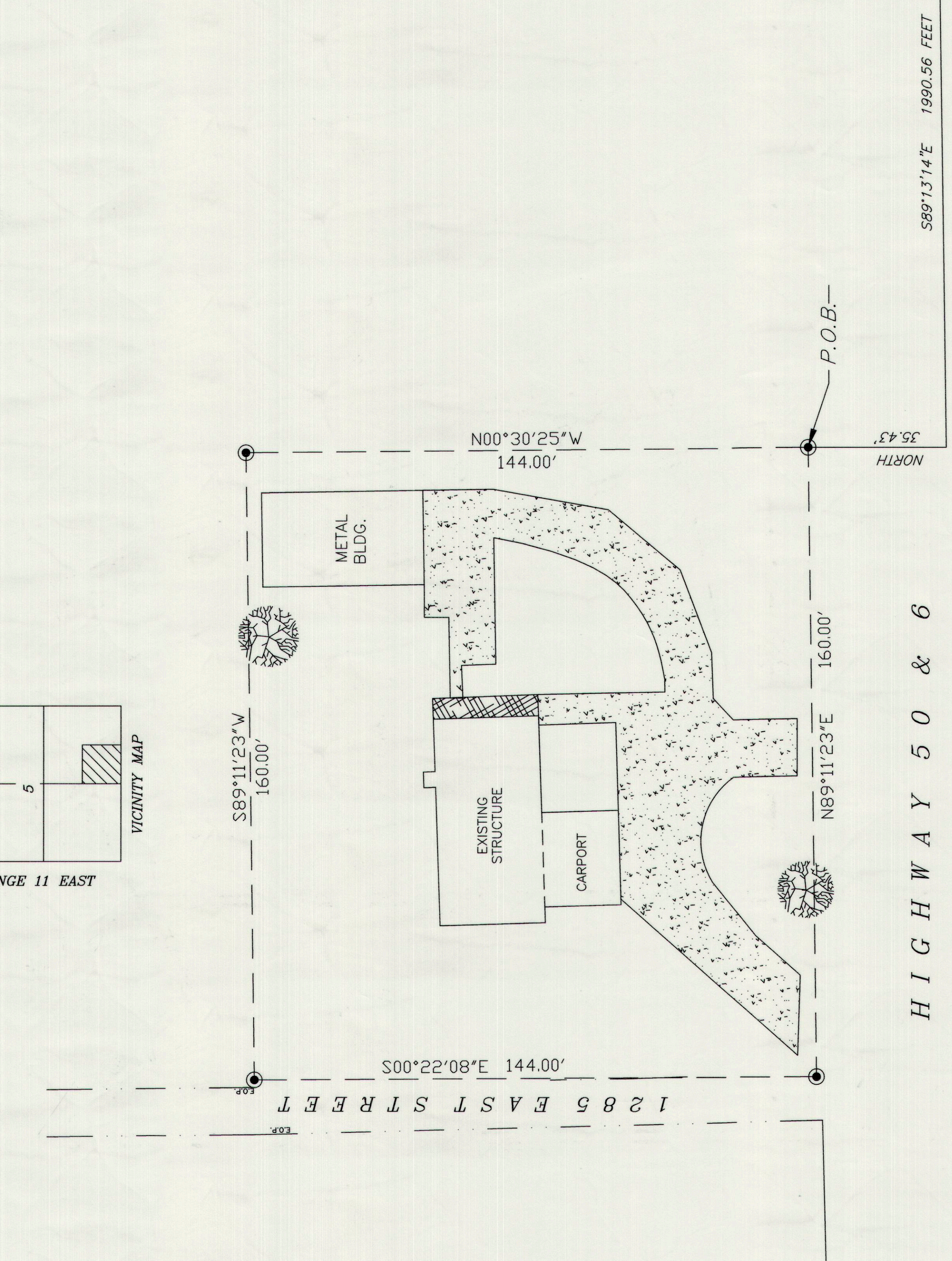
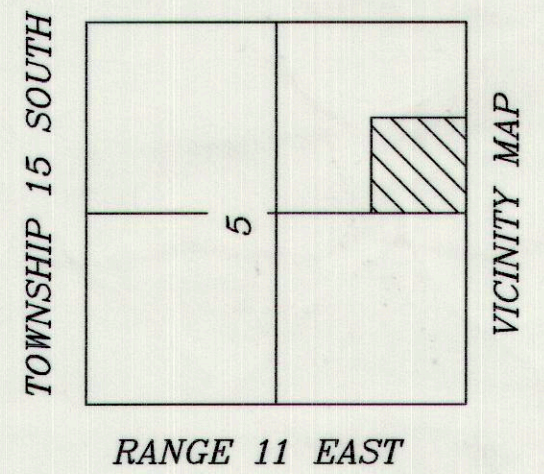
