
TOWNSHIP 12 SOUTH, RANGE 8 EAST, SECTION 33, SALT LAKE BASE AND MERIDIAN



NARRATIVE:
THE PURPOSE OF THIS SURVEY IS TO LOCATE EXISTING REBAR AND ALUMINUM CAPS AS SHOWN ON THE SURVEY, AND COMPARE WITH THE LOCATION OF THE NE¼ OF THE SE¼, LOT 3, THE SE¼ OF THE NE ¼, AND THE NE¼ OF THE SE¼ OF SECTION 33, TOWNSHIP 12 SOUTH, RANGE 8 EAST, SALT LAKE BASE AND MERIDIAN. NO SURVEY WAS FOUND TO REPRESENT WHO PLACED THE REBAR OR HOW THE LOCATION OF THE REBAR WAS DETERMINED. IN MY OPINION THEY WERE SET USING THE NORTH QUARTER CORNER OF SECTION 4 FOR TOWNSHIP 13 SOUTH, RANGE 8 EAST, SALT LAKE BASE AND MERIDIAN. THE ACTUAL SOUTH QUARTER CORNER FOR SECTION 33 WAS NEVER SET IN THE ORIGINAL SURVEY WHICH FALLS 182.57 FEET WESTERLY FROM THE NORTH QUARTER CORNER OF SAID SECTION 4. THE LOCATION FOR THE SOUTH QUARTER CORNER WAS ESTABLISHED BY INTERSECTING THE LINE BETWEEN THE CLOSING CORNERS AND EXTENDING THE LINE TO THE TOWNSHIP LINE. ALL OF THE NORTH QUARTER CORNER OF SECTION 33 HAD A CENTER PUNCH AND WC STAMPED ON IT, WHICH NO CENTER PUNCH WAS FOUND ON THE OTHER QUARTER CORNERS. THE QUARTER CORNER MATCHED THE SANDSTONE LEDGE TIES LISTED IN THE FIELD NOTES, BUT NO X WAS FOUND ON THE SANDSTONE.

THE BASIS OF BEARING FOR THIS SURVEY IS A LINE BETWEEN A BRASS CAP SET IN 1911 WHICH IS THE WEST QUARTER CORNER OF SECTION 33, TOWNSHIP 12 SOUTH, RANGE 8 EAST, SALT LAKE BASE AND MERIDIAN, WITH A BEARING OF EAST TO A BRASS CAP SET IN 1911 WHICH IS THE EAST QUARTER CORNER OF SECTION 33, TOWNSHIP 12 SOUTH, RANGE 8 EAST, SALT LAKE BASE AND MERIDIAN.
