

THE POINT OF BEGINNING WHICH IS THE NORTHWEST 16 CORNER OF SECTION 3 WAS DETERMINED BY THE BREAKING DOWN OF SECTION 3 AS PER THE BLM MANUAL OF SURVEYING INSTRUCTIONS.

THE FIELD WORK FOR THIS PROJECT WAS PERFORMED ON SEPTEMBER 21, 2009.
