NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO LOCATE AND DIVIDE PARCEL 1C-0949-0000 FOR EAST CARBON CITY.

SAID PARCEL 1C-0949-0000 IS SITUATED IN THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 11, TOWNSHIP 15 SOUTH, RANGE 13 EAST, SALT LAKE BASE AND MERIDIAN.

THE 2008 RECORD OF SURVEY PLAT BY TIMBERLINE ENGINEERING & LAND SURVEYING WAS ACCEPTED AND USED AS A REFERENCE FOR THIS SURVEY. SAID PLAT IS RECORDED AT FILE #476 IN THE CARBON COUNTY RECORDER'S OFFICE. PLAT NUMBERS 124 AND 203 WERE ALSO USED AS A REFERENCE.

THE BASIS OF BEARING USED FOR THIS SURVEY IS S88°48'56"E ALONG THE NORTH LINE OF THE NORTHWEST QUARTER OF SAID SECTION 11. THIS IS THE SAME BASIS OF BEARING USED ON SAID TIMBERLINE ENGINEERING & SURVEYING PLAT.
