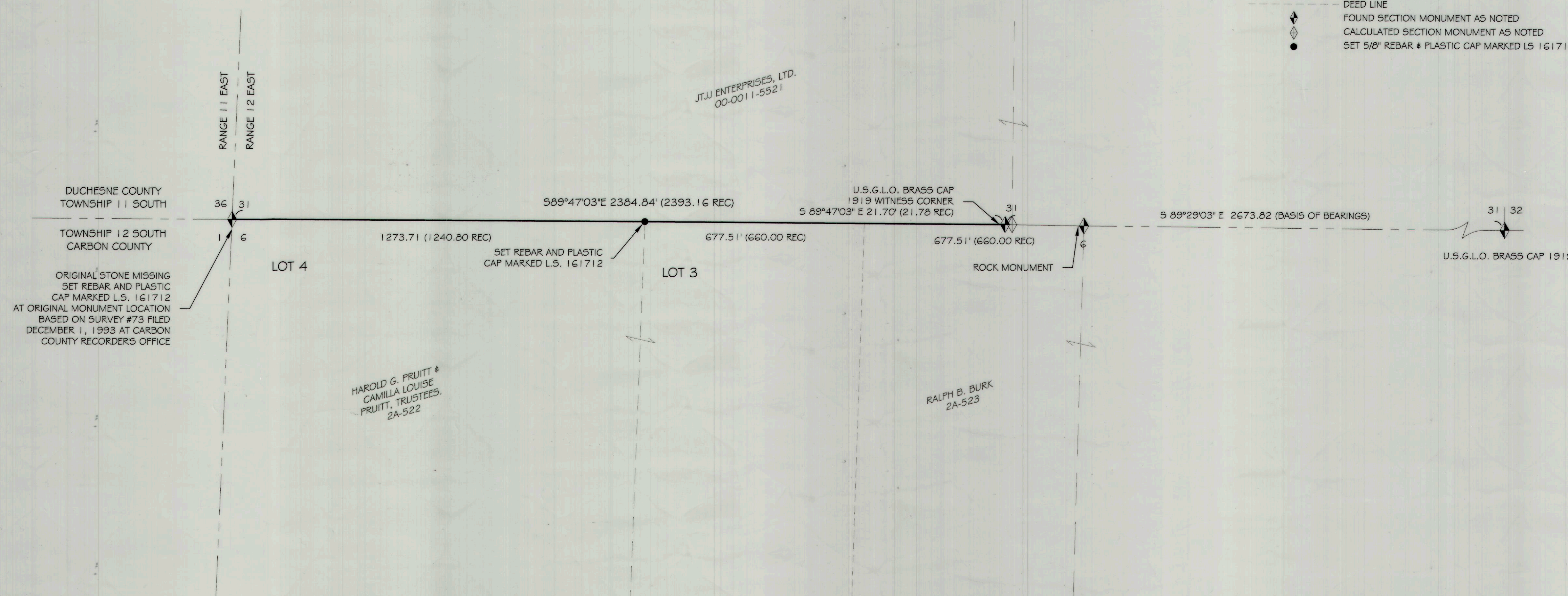
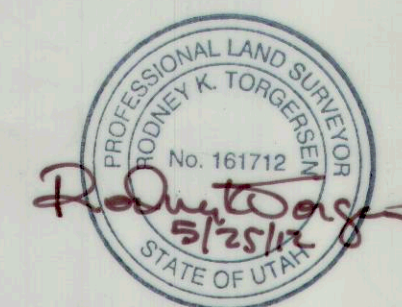
NARRATIVE:

1. THE PURPOSE OF THIS SURVEY WAS TO MONUMENT THE NORTH LINE OF LOTS 3 AND 4, SECTION 6, TOWNSHIP 12 SOUTH, RANGE 12 EAST, SALT LAKE BASE AND MERIDIAN FROM THE NORTHWEST CORNER OF SAID SECTION 6 TO THE WITNESS CORNER FOR THE SOUTH QUARTER CORNER OF SECTION 31, TOWNSHIP 11 SOUTH, RANGE 12 EAST, SALT LAKE BASE AND MERIDIAN.
2. MONUMENTS USED FOR CONTROL OF THIS SURVEY ARE THOSE BRASS CAPS AND ROCK MONUMENTS AS SHOWN ON THIS PLAT.
3. BASIS OF BEARINGS IS S 89°29'03" E BETWEEN THE WITNESS CORNER TO THE SOUTH QUARTER CORNER OF SECTION 31 AND THE SOUTHEAST CORNER OF SECTION 31, TOWNSHIP 11 SOUTH, RANGE 12 EAST, SALT LAKE BASE AND MERIDIAN, AS SHOWN ON TORGERSEN ENGINEERING SURVEY FOR LUCINDA B. WILD FILED DECEMBER 1, 1993 AS RECORD OF SURVEY #73, CARBON COUNTY RECORDER'S OFFICE.
