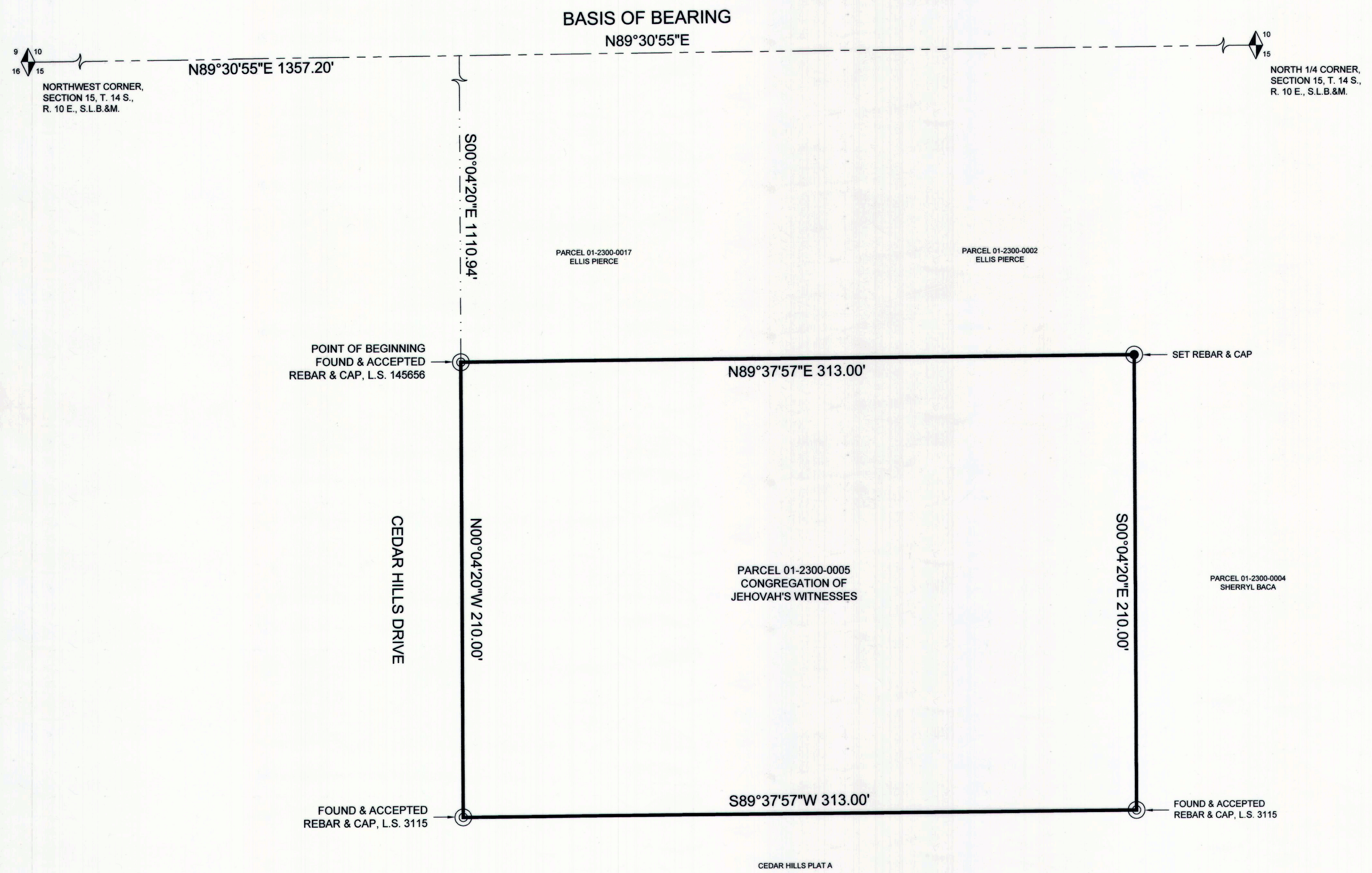

BEGINNING AT A POINT WHICH LIES NORTH 89°30'55\"/>

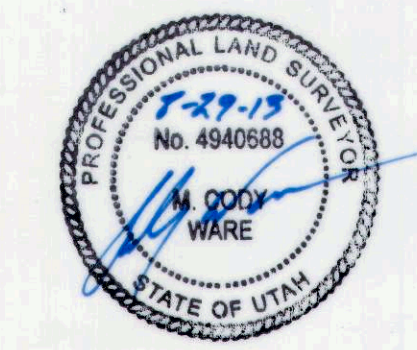
CONTAINS 5.37 ACRES.

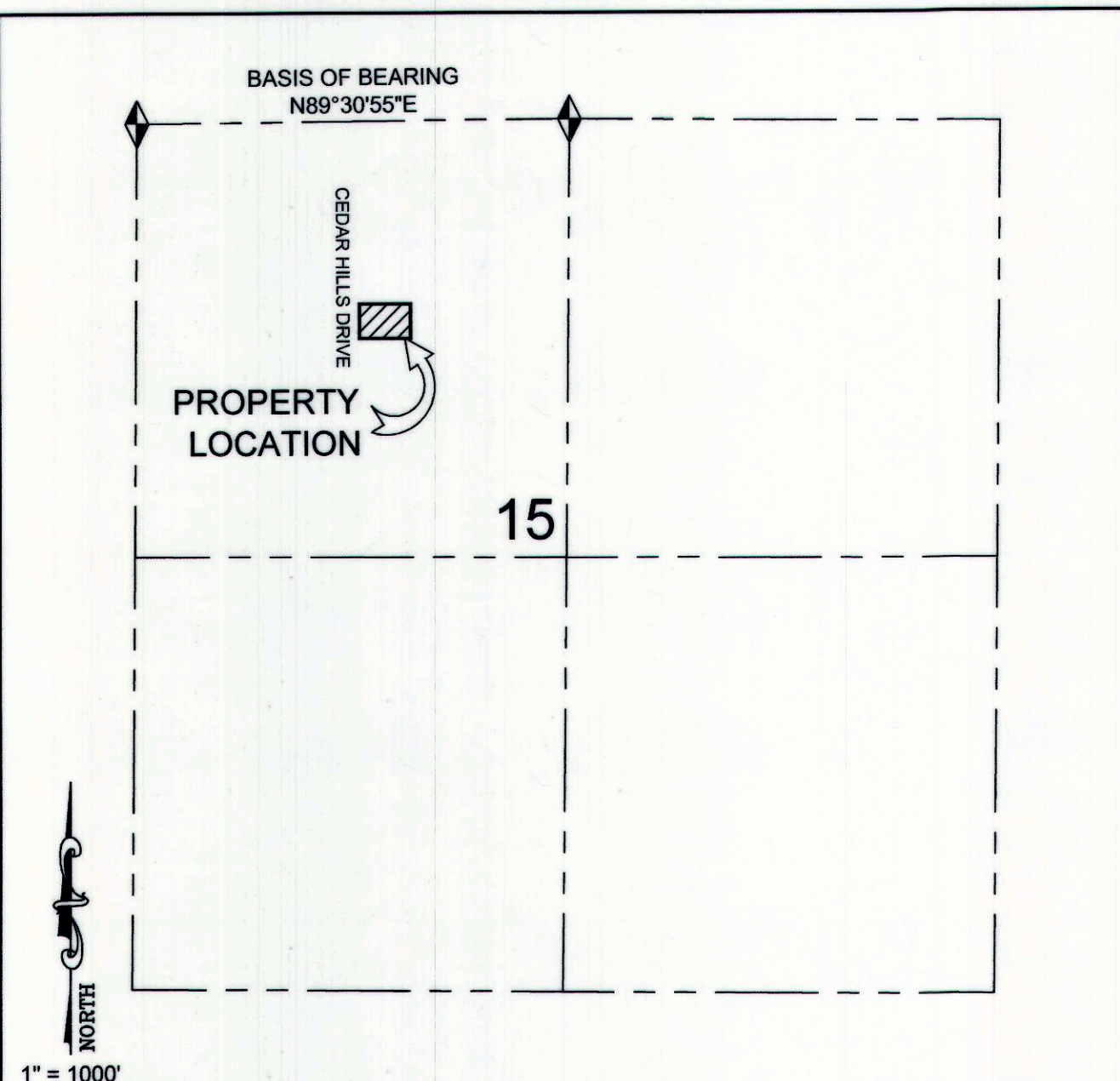

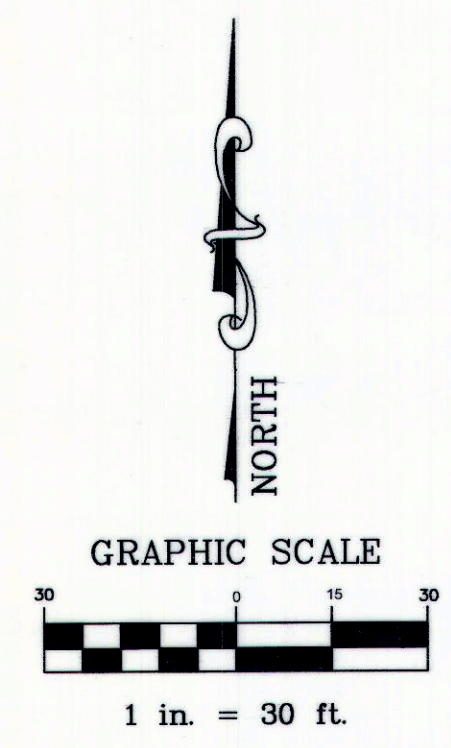
