



### **NARRATIVE**

THE DIMENSIONS AND BEARINGS SHOWN HEREON SHALL YIELD TO AN ACCURATE BOUNDARY LINE RETRACEMENT BASED ON FIELD MEASUREMENTS AND FOUND MONUMENTS.


## LEGEND **CONSOLIDATED BOUNDARY** SECTION LINE
