The boundaries of the JIMMY B. & CAROLINE E. FEICHO property labeled herein as "D", Parcel No. 2A-0180-0002 were not determined by this survey. This parcel was surveyed in July 1993 by Bruce T. S. Ware. The plat of said survey is found in the office of the Carbon County Recorder as File No. 53 of Record of Survey maps. The Ware plat shows a bearing of South along the line from the Carbon County monument representing the Northeast Corner of Section 19 prior to the 2000 B.L.M. Dependent Resurvey. This same line has a bearing of South 014°36' East when related to the B.L.M. survey bearing base. The record bearings of the Feicho parcel, Parcel No. 2A-0180-0002 are shown herein, rotated 014°36' counterclockwise to coincide with the bearing base established by the B.L.M. Dependent Resurvey, being the bearing base employed by this survey.

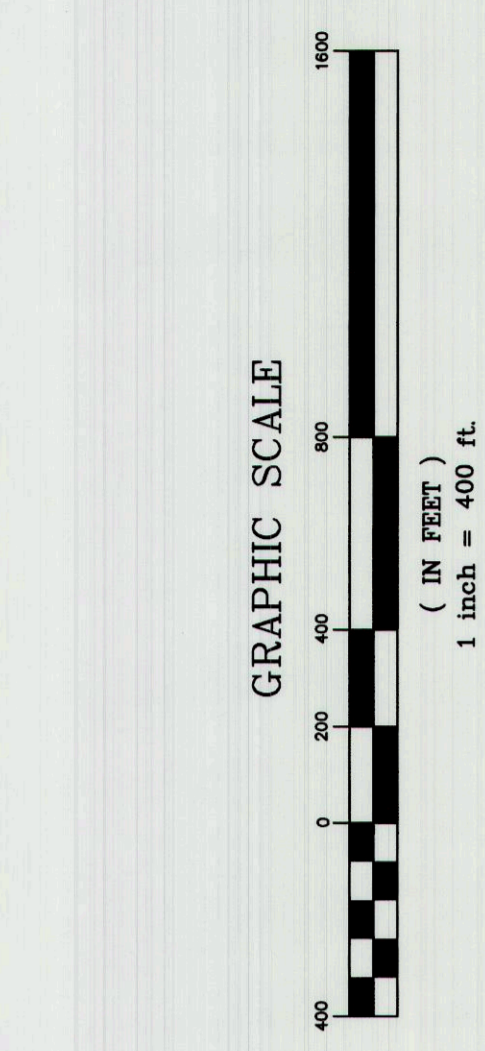

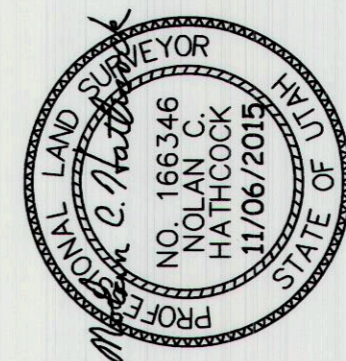
