THE PURPOSE OF THIS SURVEY IS TO LOCATE THE EAST BOUNDARY LINE OF PARCEL 02-1297-0000, DESCRIBED AT BOOK 447, PAGE 536 FOR JOSEPH SALAZAR.
 THE BASIS OF BEARING USED FOR THIS SURVEY IS NORTH 89°22'58" EAST BETWEEN THE SOUTH QUARTER CORNER AND THE SOUTHEAST CORNER OF SECTION 21, TOWNSHIP 14 SOUTH, RANGE 10 EAST, SALT LAKE BASE AND MERIDIAN.
 THE PROPERTIES SHOWN HEREON WERE LOCATED BY SURVEYING THE EXISTING OCCUPATION LINES (FENCES, ROAD IMPROVEMENTS, ETC.) AND POSITIONING THE BOUNDARY LINES TO BEST FIT THEM. PARCELS WERE ALSO ROTATED 00°30' COUNTERCLOCKWISE TO FIT SAID OCCUPATION LINES.

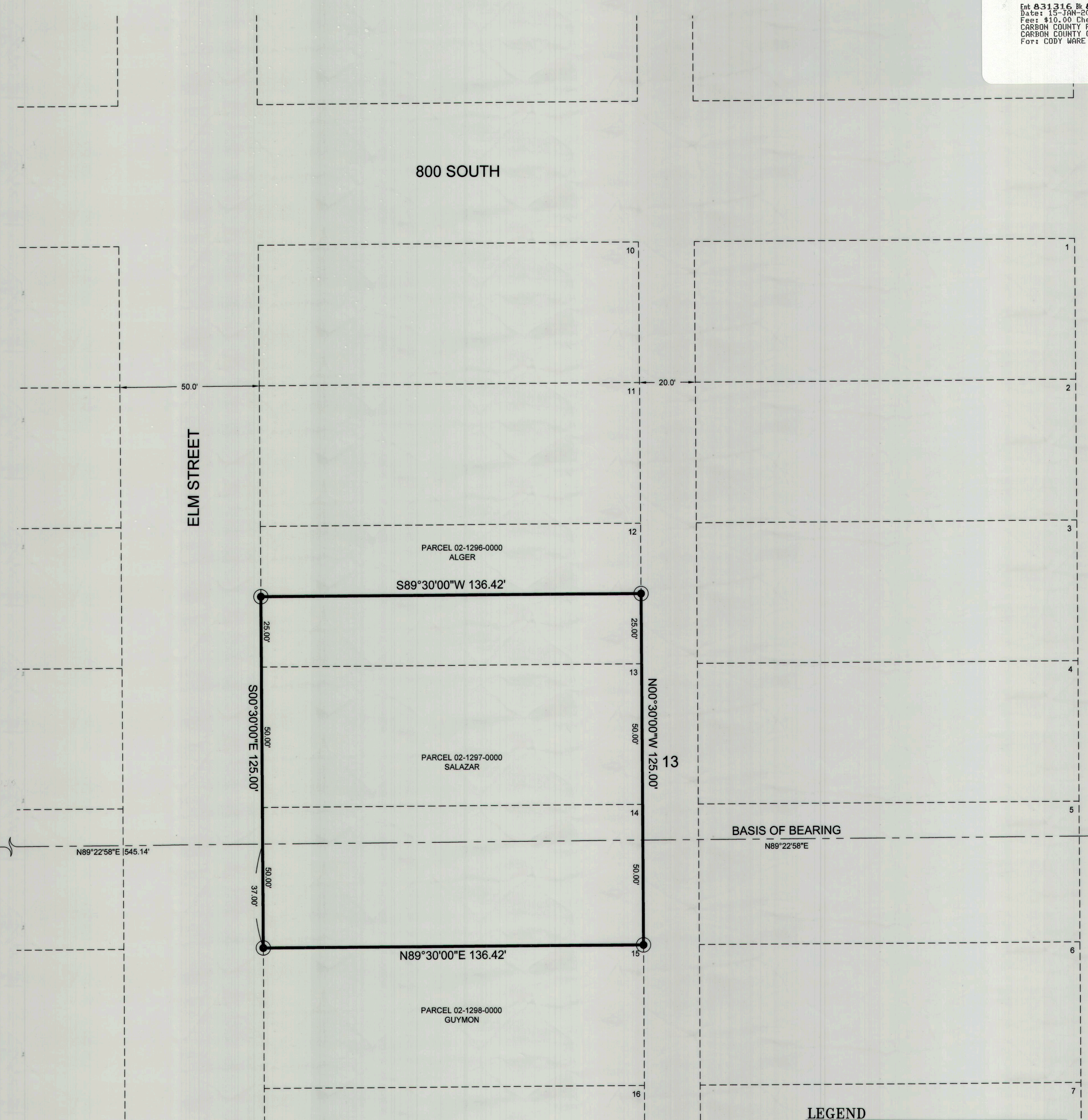

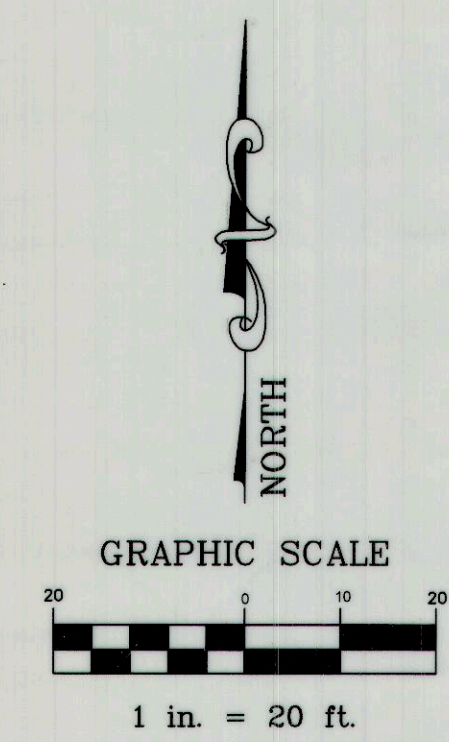


SOUTH 1/4 CORNER, SECTION 21, T. 14 S., R. 10 E., S.L.B.&M. N89°22'58\"/>

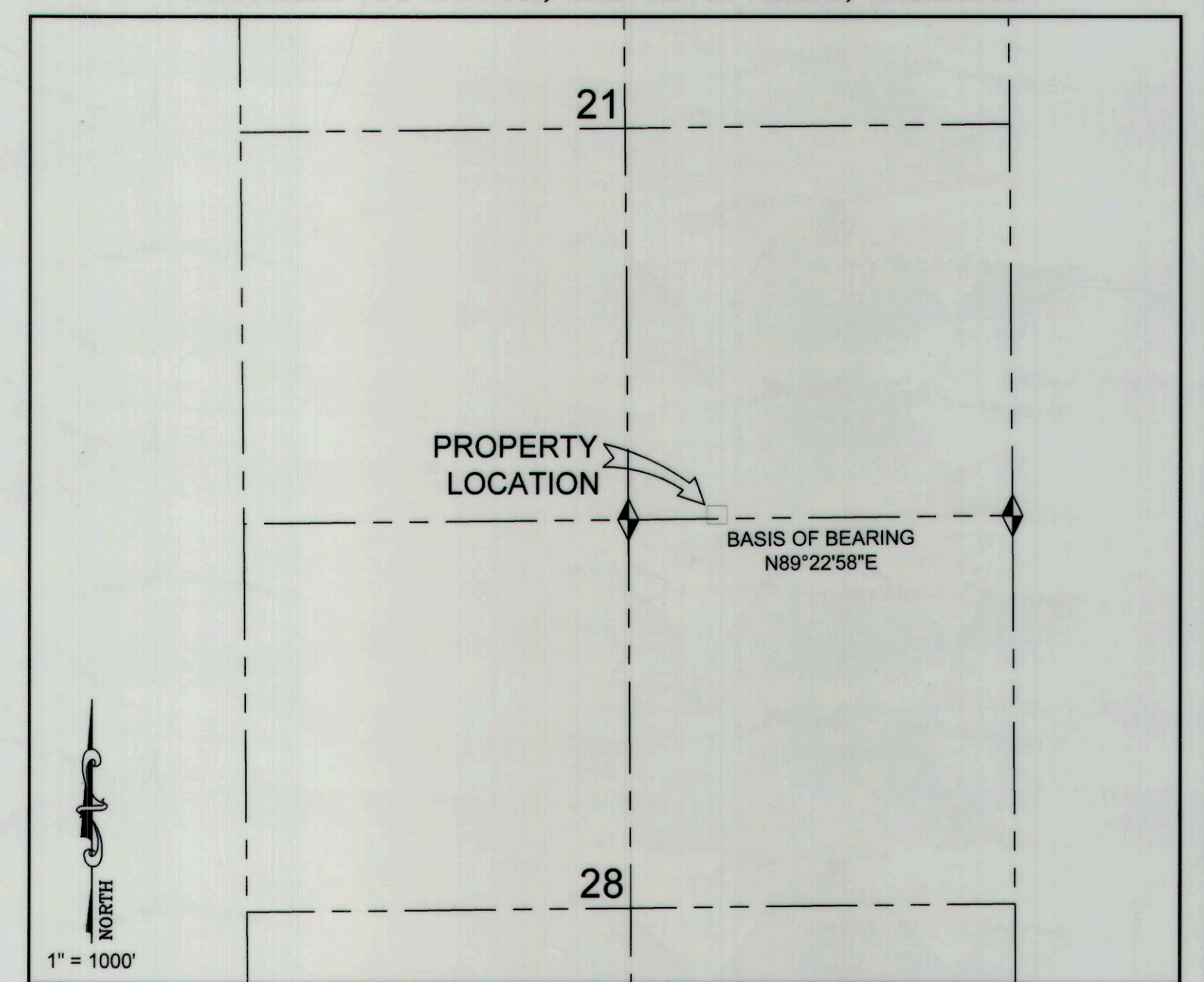
SOUTHEAST CORNER, SECTION 21, T. 14 S., R. 10 E., S.L.B.&M. N89°22'58\"/>
