

1. THE PURPOSE OF THIS SURVEY WAS DIVIDE OUT A 5.00 ACRE PARCEL OUT OF PARCEL 2-2270-3 AND TO STAKE CERTAIN CORNERS OF THE HEREON DESCRIBED PARCEL OF LAND.

2. BASIS OF BEARING IS N00°01'36"E BETWEEN THE WEST QUARTER CORNER AND THE NORTHEAST CORNER OF SECTION 22, T. 15 S., R. 10 E., S.L.B. & M.

3. THE FOLLOWING SURVEY DATA OR SURVEY PLATS WERE USED TO HELP ESTABLISH THE CORNERS OF THE HEREON SHOWN PARCELS OF LAND.

#1 - THE FEICHKO SUBDIVISION NO. 2 AMENDMENT NO. 1 - PLAT IS ON FILE AT THE CARBON COUNTY RECORDER'S OFFICE. SAID PLAT SHOWS THE

ORIGINAL LAYOUT OF THE LOTS AND CAN BE FOUND AS ENTRY NUMBER 155277, BOOK 3 O FLATS PAGE 212. SAID SURVEY WAS PREFORMED IN 1980 WHICH PREDATES THE OTHER SURVEYS IN THE AREA.

#2 - CARBON COUNTY DRAWING SHOWING SECTION DATA FOR SAID SECTION 22 WAS PROVIDED BY BEN GRIMES, FORMER COUNTY SURVEYOR.

SECTION CORNER MONUMENTS ARE DATED 1985.

DESCRIBE FINDING A COUNTY MONUMENT.

4. THE LOCATIONS FOR THE NORTH QUARTER CORNER, THE CENTER QUARTER CORNER, AND THE EAST QUARTER CORNER OF SECTION 22 SHOWN

#3 - B.L.M. SURVEYED ALONG THE WEST LINE OF SAID SECTION BACK IN 1990. SAID PLAT IS ON FILE AT THE STATE OFFICE AND THE NOTES

HEREON AS NOT FOUND WERE RE-ESTABLISHED BASED ON INFORMATION FROM THE DRAWING FROM CARBON COUNTY SURVEY DEPARTMENT.

5. USING THE CARBON COUNTY DRAWING MENTIONED ABOVE, THE POSITION OF THE WEST QUARTER CORNER IS DIFFERENT THAN WHAT WAS USED TO STAKE THE CORNERS OF THE FEICHKO SUBDIVISION. THE SUBDIVISION PLAT SHOWS THE WEST QUARTER CORNER IN THE MIDDLE OF A PROPOSED 66.00 FOOT WIDE COUNTY ROAD 2640 FEET FROM THE NORTHWEST CORNER OF THE SECTION. THE DISTANCE FROM THE CARBON COUNTY DATA IS 2672.10 FEET.

6. THE LOCATION FOR THE NORTHEAST CORNER OF FEICHKO SUBDIVISION WAS ESTABLISHED USING THE FEICHKO SUBDIVISION PLAT AND WAS DETERMINED TO BE THE BEST EVIDENCE OF THE LOCATION OF THIS CORNER AND THE STARTING POINT OF THE HEREON STAKED NEW PARCEL OF LAND. SAID PLAT SHOWS A STONE CORNER AT THE NORTHWEST CORNER OF SECTION 22, WHICH IF THE CURRENT POSITION IS USED (MARKED BY A CARBON COUNTY 1985 MONUMENT) AND THE SUBDIVISION IS PLOTTED IT CLOSELY MATCHED THE LOCATION OF FENCE LINES RUNNING IN A NORTH TO SOUTH DIRECTION ALONG THE LOT LINES OF THE SUBDIVISION AND ALSO MATCH THE NORTH LINE OF SUBDIVISION. THIS KNOWLEDGE OF KNOWING THAT THE ORIGINAL B.L.M. SURVEY PLATS SHOW 80 CHAINS ALONG THE WEST LINE OF SECTION 22 AND THAT THE NORTHWEST CORNER WAS A STONE THAT WAS LATER REPLACED BY A COUNTY MONUMENT PLOTS THE SUBDIVISION AS SHOWN HEREON WAS MY REASONING IN STARTING THE NEW PARCEL WERE IDID.
