ALLRED, A PROFESSIONAL LAND SURVEYOR HOLDING UTAH CERTIFICATE NO. 11179291, DO HEREBY CERTIFY THAT THE PLAT SHOWN HEREON HAS BEEN PREPARED FROM A FIELD SURVEY MADE UNDER MY DIRECTION AND CORRECTLY SHOWS THE DIMENSIONS AND MONUMENTS OF THE PROPERTY DESCRIBED TO THE BEST OF MY KNOWLEDGE AND BELIEF.

Located within the Northwest Quarter of the Southeast Quarter of Section 1, Township 15 South, Range 10 East, SLB&M.

### **DEED DESCRIPTION:**

Beginning at a point 572.50 feet South of the Northwest Corner of the Northwest Quarter of the Southeast Quarter, Section 1, Township 15 South, Range 10 East, SLB&M, which point is on the North boundary of the State Road right-of-way; and running thence South 47°06' East, 485 feet to the 30" culvert under highway; thence North 45°18 East, 380 feet; thence North 10°00' East, 290 feet to Willis Butolph fence; thence South 70°00' West, 213 feet; thence North 79°30' West, 65 feet; thence North 69°28' West, 72 feet; thence North 74°32' West, 105 feet; thence Southwesterly 380 feet, more or less, to a point of beginning.

# Excepting therefrom a parcel of land in fee for the widening of the existing highway State Route 6 described as

Beginning in the existing Northeasterly right-of-way line of said State Route 6 at the Southwest Corner of said entire tract, which point is 3227.32 feet South 00°06'04" East along the Quarter Section Line from the North Quarter Corner of said Section 1, and running thence North 45°13'41" East, 53.59 feet; thence South 47°06'36" East, 52.14 feet; thence South 42°53'24" West, 32.04 feet; thence South 47°06'36" East, 453.69 feet; thence South 45°18'00" West, 21.61 feet to said existing Northeasterly right-of-way; thence North 47°06'00" West, 507.11 feet along said Northeasterly right-of-way line to the point of beginning.

Beginning at a point which is located S 00°26'17" E, 578.39 feet along the Center Section Line and East, 204.63 feet from the Northwest Corner of the Northwest Quarter of the Southeast Quarter of Section 1, Township 15 South, Range 10 East, SLB&M, said point being on the Northeasterly right-of-way line of SR-6; thence S 47°26'49" E, 252.18 feet along said right-of-way to the centerline of a 30" culvert under the highway; thence N 44°21'24" E, 364.00 feet; thence N 08°56'09" E, 292.38 feet to an existing fence line; thence S 68°56'09' W, 213.00 feet; thence S 43°31'56" W, 416.54 feet to the point of beginning. Containing 2.90 acres, more or less.

For bearings shown as measured (MES.), S 00°26'17" E, between the West Quarter Corner and the East Quarter Corner of Section 1, Township 15 South, Range 10 East, SLB&M.

# SURVEYORS NARRATIVE:

Surveyed at the request of Joanne Cocciolo to subdivide the parcel described on the Warranty Deed recorded as Entry No. 133532, Bk. 695, Pg. 210, Official Records of the Carbon County Recorder. Mrs. Cocciolo also requested that this surveyor monument and describe said subdivided parcel as shown hereon.

The survey was based on instructions in the field by Mrs. Cocciolo, said Warranty Deed, a Record of Survey by Art Barker, L.S. No. 102312 recorded as Entry No. 108356, Bk. 578, Pg. 10, Official Records of said Recorders Office, found Survey Monuments and found Section Monuments. The Section was subdivided in accordance with the BLM Manual of Surveying Instructions.

# ADDITIONAL NOTE:

There exists some documentation as to the existence of a 20' wide right-of-way across the Northwesterly line of surveyed parcel. This survey makes no attempt to determine the status of said right-of-way.
