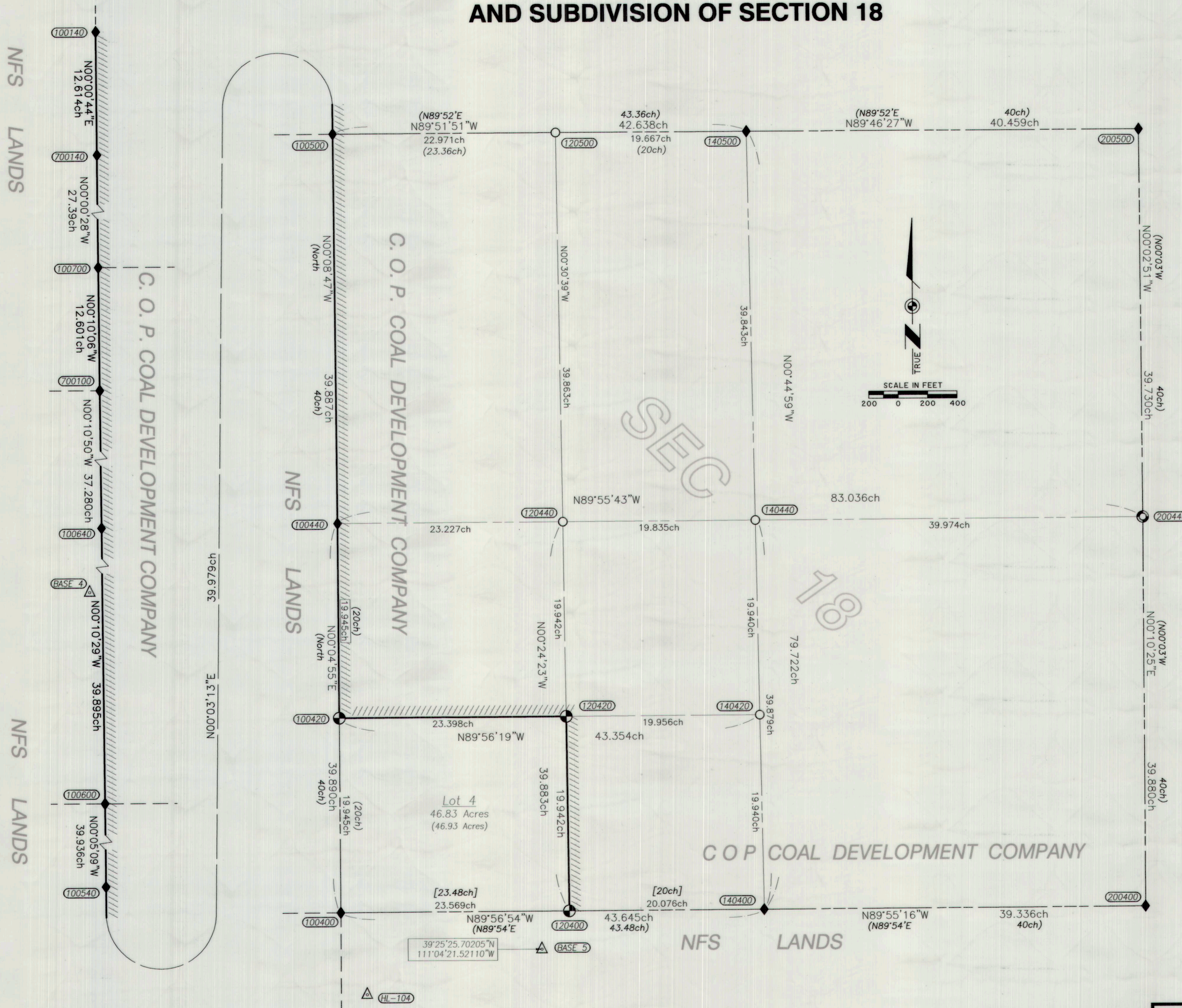
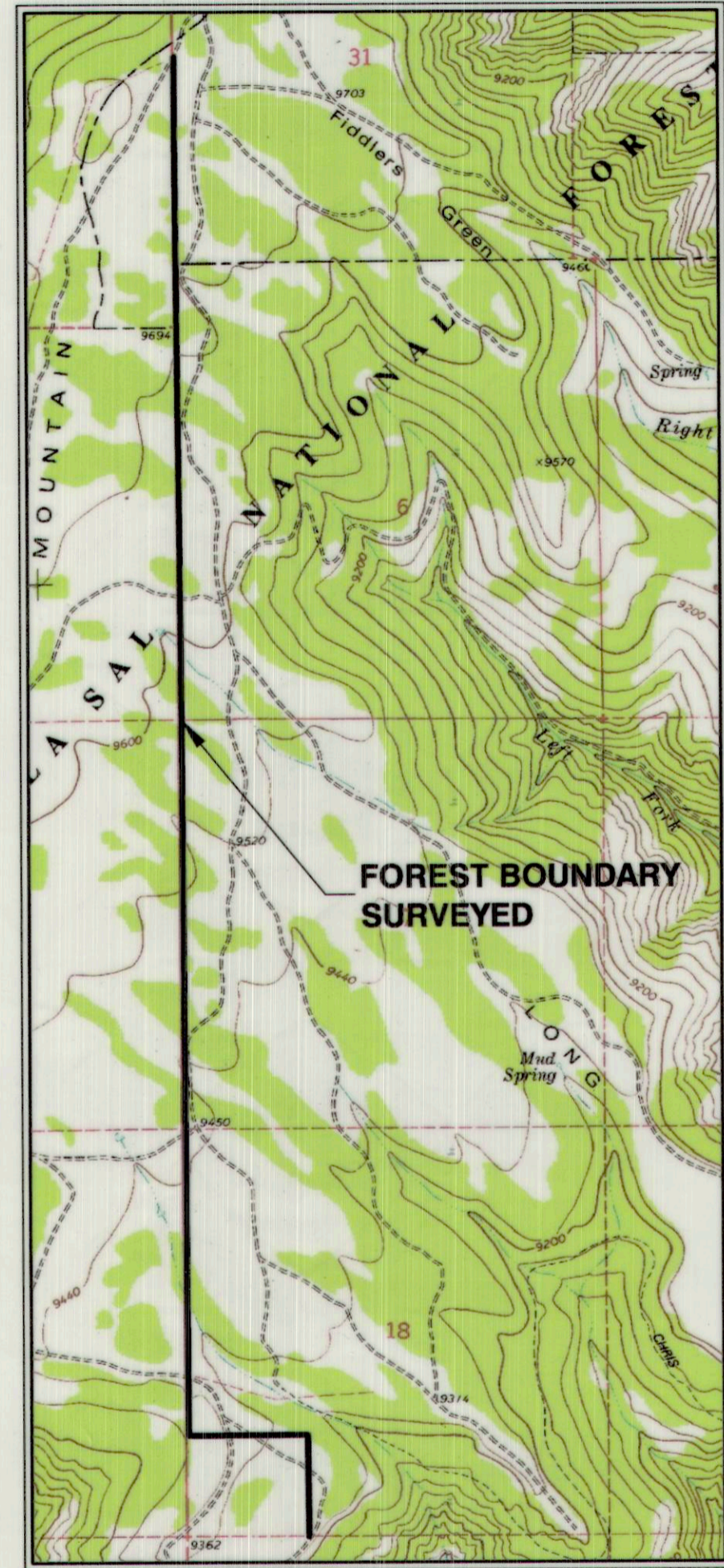

PURPOSE OF SURVEY

THE PURPOSE OF THIS SURVEY IS TO LOCATE, MONUMENT, MARK AND POST THE BOUNDARIES OF THE MANTI-LA SAL NATIONAL FOREST WITHIN SECTION 18, TOWNSHIP 16 NORTH, RANGE 8 EAST, SALT LAKE MERIDIAN.

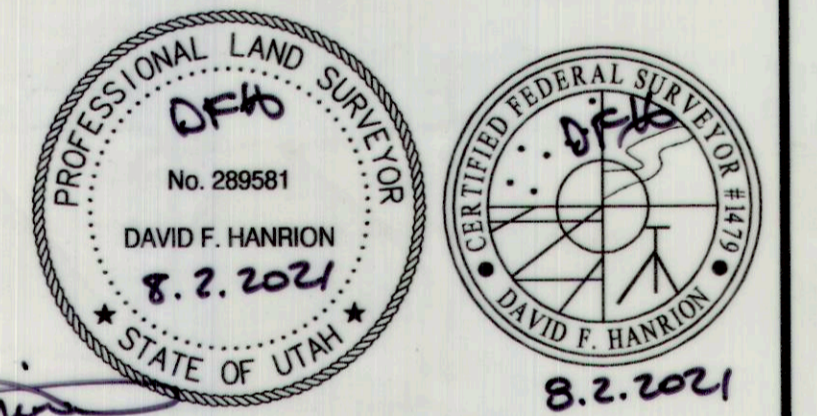
BASIS OF BEARINGS

THE NORTH AMERICAN DATUM 1983 GEOGRAPHIC POSITIONS OF ALL CORNERS WERE DERIVED FROM A NATIONAL GEODETIC SURVEY'S ONLINE POSITIONING USER SERVICE (OPUS) AT "BASE 10" BEING:
LAT: 39°27'26.50068"N, LON: 111°04'40.12252"W, (REF FRAME NAD_83, 2011-EPOCH 2010.0000), USING BASE STATIONS "MCO6" (PID DL3522), "PUC2" (PID DP9024) AND "MCO4" (PID DH6916), AND WERE CARRIED FORWARD VIA RTK OBSERVATIONS. THE MEAN GEODETIC BEARINGS OF LINES AND HORIZONTAL EQUIVALENTS OF GROUND DISTANCES (CHAINS) ARE SHOWN HEREON.
