



THE PURPOSE OF THIS SURVEY IS TO LOCATE PARCEL 1A-0389-0016 DESCRIBED AT ENTRY 816847, BOOK 780, PAGE 222 IN THE OFFICIAL RECORDS OF THE CARBON COUNTY RECORDER. SAID PARCEL IS DESCRIBED FROM THE NW CORNER OF THE NE 1/4 OF THE SW 1/4 OF SECTION 13. NO MONUMENT WAS FOUND AT THIS POSITION AND USING THE CALCULATED POSITION OF SAID CORNER CREATED OBVIOUS

THE BOUNDARY OF SAID PARCEL WAS LOCATED BY SURVEYING THE EXISTING OCCUPATION LINES (FENCES, ROAD IMPROVEMENTS, ETC.) AND POSITIONING THE BOUNDARY TO BEST FIT THEM.

THE BASIS OF BEARING USED FOR THIS SURVEY IS SOUTH 00°15'39" EAST BETWEEN THE WEST QUARTER CORNER AND THE SOUTHWEST CORNER OF SECTION 13, TOWNSHIP 13 SOUTH, RANGE 9 EAST, SALT LAKE
