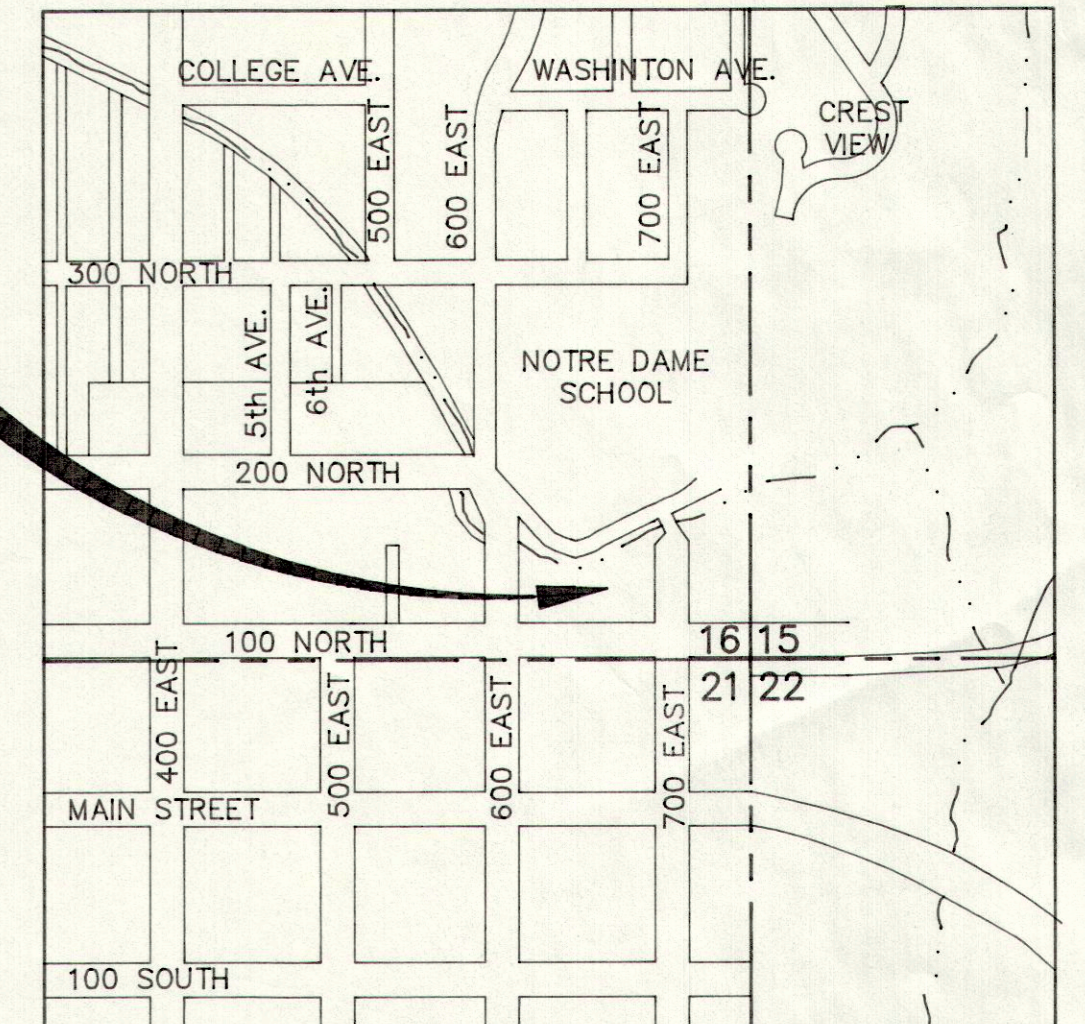




AREA SHOWN ENLARGED AT THE LEFT

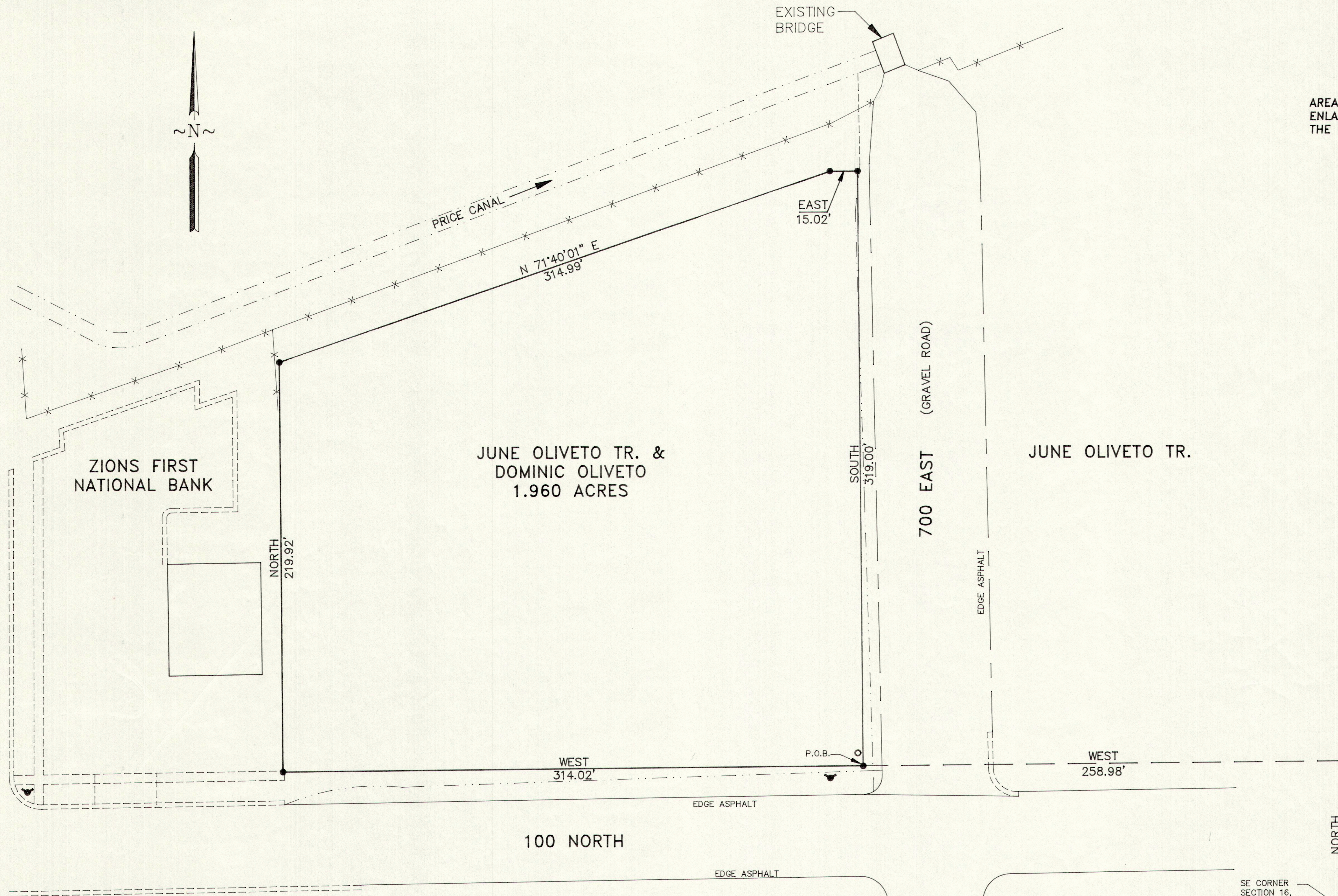
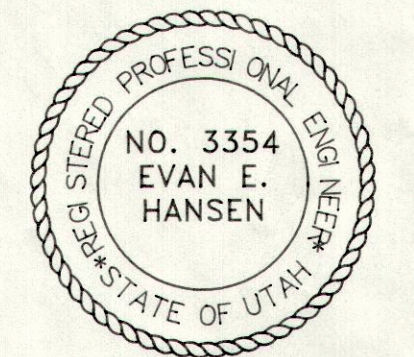
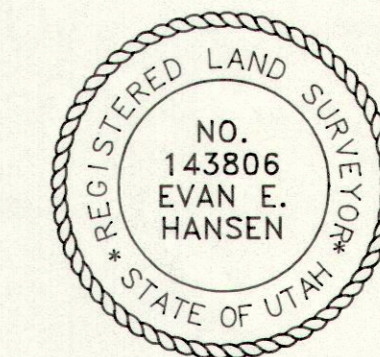
