A 50 FT. WIDE RIGHT OF WAY MORE PARTICULARLY DESCRIBED AS: BEGINNING AT A POINT 2537.91 FT. SOUTH AND 2627.83 FT. WEST FROM THE N.E. CORNER OF SECTION T, T 145, R 10E, S.L.B. &M., SAID POINT BEING ON THE & SECTION LINE; THENCE NO 15'34"W 198.88 FT. ALONG SAID LINE TO A POINT ON A 7 2.21 FT. RADIUS CURVE TO THE RIGHT; THENCE NORTHEASTERLY 213.64 FT. ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 15051'04" (CHORD BEARS N 29030"E 212.95 FT., CURVE IS CONCAVE TO THE NORTHWEST); THENCE N 37° 26'00" E 500.59 FT. TO THE EXISTING COUNTY ROAD RIGHT OF WAY; THENCE SOUTHEASTERLY ALONG SAID RIGHT OF WAY HAVING A BEARING AND DISTANCE OF 5 42° 45'E 50.74 FT. THENCE \$ 37° 26'00" W 491.94 FT. TO A POINT ON A 722.21 FT. RADIUS CURVE TO THE LEFT; THENCE SOUTHWESTERLY 386.48 FT. ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 30°39'39" TO THE POINT OF BEGINNING (CHORD BEARS \$ 22° 06'09" W 381.88 FT., CURVE IS CONCAVE TO THE NORTHWEST).
