ORDINANCE NO. 1130 - 53

AN ORDINANCE DECLARING THE ANNEXATION OF, AND EXTENDING OF, THE CORPORATE LIMITS OF THE CITY OF PRICE, COUNTY OF CARSON, STATE OF UTAH, OF REAL PROPERTY, BEING A PART OF THE NORTHEAST QUARTER OF SECTION 16, TOWNSHIP 14 S., RANGE 10 East, SALT LAKE MERIDIAN.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PRICE, COUNTY OF CARSON, STATE OF UTAH, AS FOLLOWS:

SECTION 1. That whereas more than three-fourths of all members of the City Council of the City of Price, County of Carson, State of Utah, on the 27th day of April, A. D., 1953, voted for the annexation of the hereinafter described property to the City of Price, County of Carson, State of Utah,

IT IS HEREBY DECLARED that the real property lying contiguous to the corporate limits of the City of Price, County of Carson, State of Utah, and hereinafter described, be, and the same is hereby, annexed to the City of Price, County of Carson, State of Utah, and the limits of the said City of Price, County of Carson, State of Utah, are hereby extended to embrace the said real property which is particularly bounded and described as follows, to-wit:

Beginning at the Northwest corner of Block 19, Parkdale Addition to the City of Price, thence South 137 feet to the Southwest corner of Block 12, thence East 762 feet to the Southwest corner of Block 14, thence North 667 feet to the Southwest corner of Block 17; thence West 381 feet to the Southwest corner of Block 18; thence North 650 feet more or less to the present City limits thence West 381 feet to the point of beginning, which description includes all of Blocks 19-12-13.

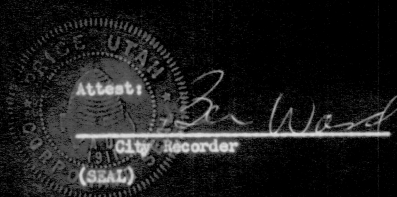
SECTION 2. This Ordinance shall take effect and be in full force and operation twenty days after its publication.

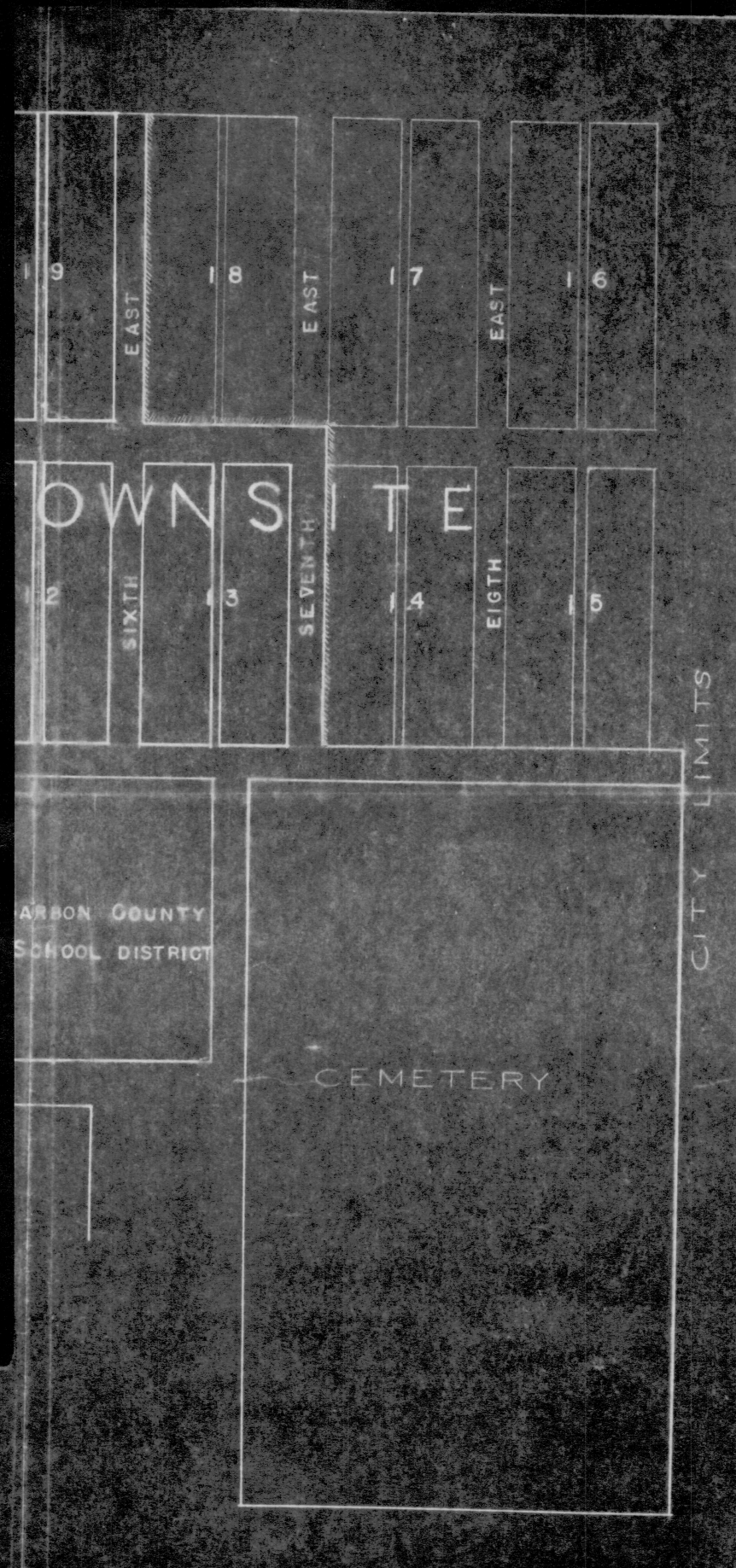
