Thence N 72° 30' E Thence W 264' Thence N 75° E Thence W 313' Thence S 79° 30' E Thence E 577' to Place of beginning, that the street opposite G Street is 40' wide and the one opposite F Street is 22' wide and that 8th & 9th streets are as wide as shown on this Plat and that Lots 1-5 Block 1 are each 100x214 1/2 and lots 2-4 are each 50x214 1/2 Block 1 and that Lot 3 Block 1 is 60x214 1/2 and that Lots 8-9 Block 2 are each 100x214 1/2 and that lots 2-3 4-5-6-7-10-11-12-13-14-15 Block 2 are each 50x214 1/2 and that Lots 1-16 Block 3 are each 100x214 1/2. 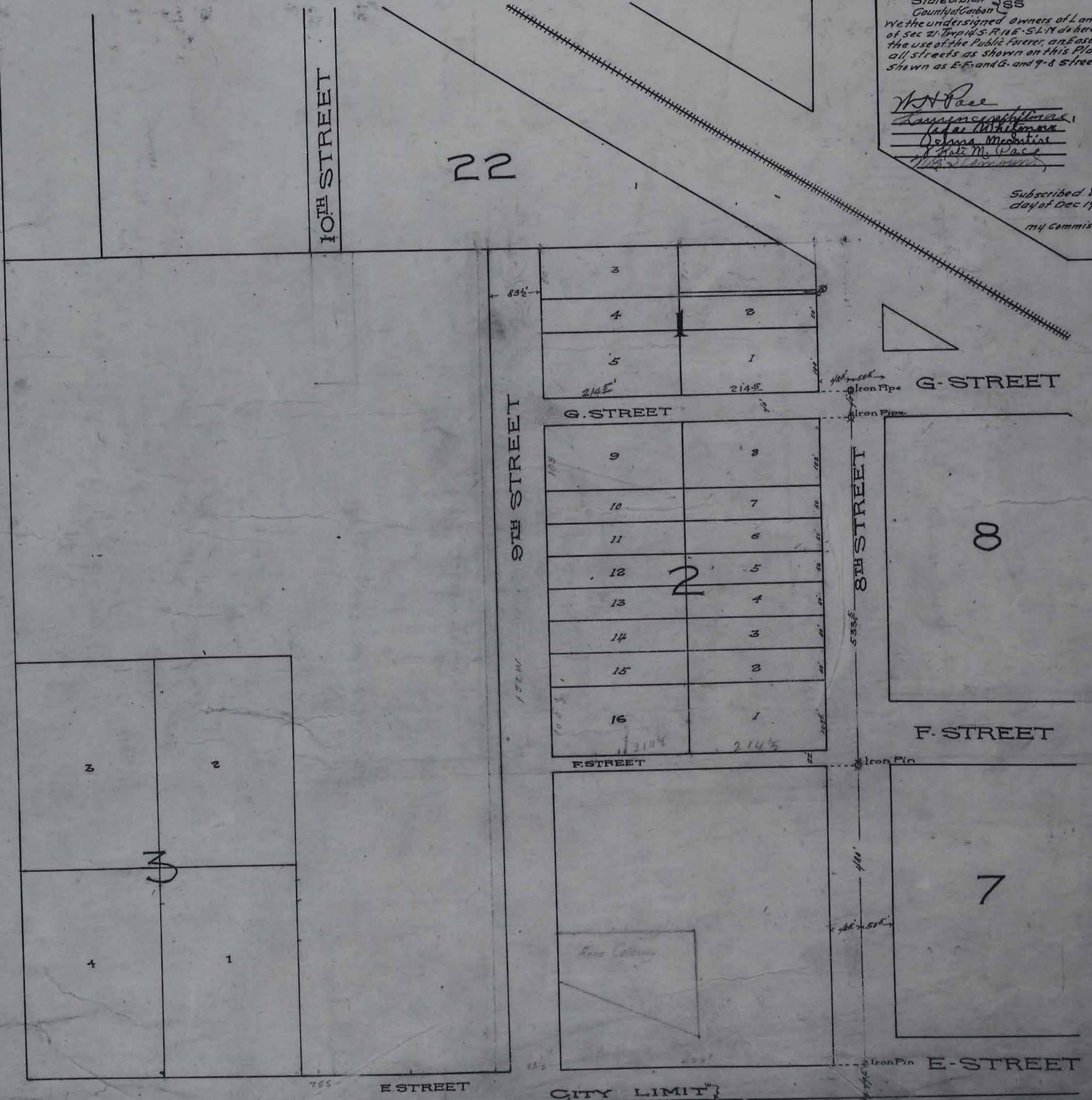
