AN ORDINANCE EXTENDING THE LIMITS OF THE TOWN OF HELPER.  
As it Ordained by the President and Board of Trustees of the Town of Helper:

Section 1. That inasmuch as a majority of the owners of the real estate hereinafter described, and which real estate lies contiguous to the corporate limits of the Town of Helper have filed their petition asking to have the corporate limits of the Town of Helper extended so as to include the real estate hereinafter described, and the said petitioners having caused an accurate plat and map of said territory to be made under the supervision of the County Surveyor of Carbon County, Utah, a competent engineer, and a copy of said plat and map duly certified by said engineer having been filed in the office of the Town Clerk of the Town of Helper, and the President and Board of Trustees of said Town of Helper at the first regular meeting after the filing of said Plat and Petition having by a unanimous vote of all its members voted in favor of the annexation of the territory described in the plat and petition, and the extension of the limits of said Town, accordingly:

It is therefore ordered, declared and ordained that the corporate limits of the Town of Helper be and the same is hereby extended to cover all the territory and real estate included within the following described boundary: Commencing at a point 1320 feet north of the Southwest corner of Section 12, Township 13 South, Range 10 E 3 L N, and running thence west 2640 feet; thence north 1320 feet; thence west 7820 feet; thence north 1320 feet; thence west 1320 feet; southwest corner of Section 15, Township 13 South, Range 9 E 3 L N; thence north 2640 feet; thence east 1320 feet; thence south 1320 feet; thence east 1320 feet; thence south 1320 feet; thence east 5280 feet; thence north 2640 feet; thence west 1320 feet; thence south 1320 feet; thence east 1320 feet; thence south 2640 feet; thence east 1320 feet; thence south 2640 feet; thence east 7820 feet; thence south 2640 feet; thence east 5280 feet to place of beginning.

Section 2. This ordinance shall take effect after due publication. Passed by the President and Board of Trustees of the Town of Helper this 24th day of November, A.D. 1913, and ordered to be published.
