

An Ordinance amending blocks 22 and 23 of Plat of Williams Addition, Price City Survey, to Price, a municipal corporation.

Be it Ordained by the City Council of Price, Utah:

Section 1.- That, whereas the provisions of the statutes of the State of Utah relative to the extension of corporate limits of cities, having been complied with, now therefore Blocks 22 and 23 of Plat of Williams Addition, Price City Survey, are hereby annexed to the corporate limits of Price, and said corporate limits are hereby extended accordingly.

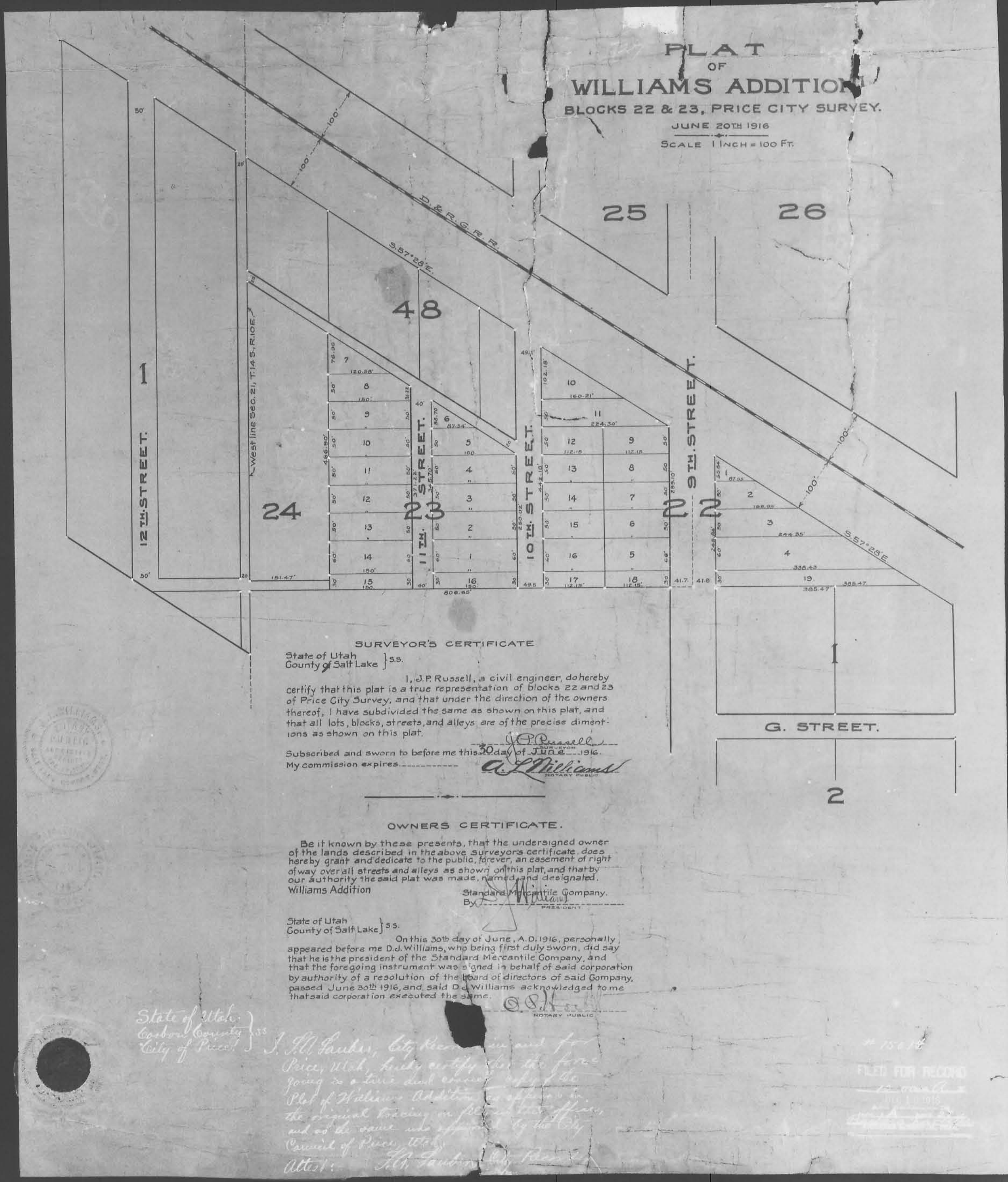
