ORDINANCE NO. 115-56

AN ORDINANCE DECLARING THE ANNEXATION OF, AND EXTENDING OF THE CORPORATE LIMITS OF THE CITY OF PRICE, CARBON COUNTY, STATE OF UTAH, OVER REAL PROPERTY COMPRISING BLOCK 15 OF PARK DALE TOWNSHIP OF PRICE, UTAH.

BE IT ORDAINED by the City Council of the City of Price, County of Carbon, State of Utah, as follows:

SECTION I. That whereas, more than two-thirds of all members of the City Council of the City of Price, County of Carbon, State of Utah, on the 8th day of October A.D., 1956, voted for the annexation of the hereinafter described property to the City of Price, County of Carbon, State of Utah.

IT IS HEREBY DECLARED that the real property lying contiguous to the corporate limits of the City of Price, County of Carbon, State of Utah, and hereinafter described, be and the same is hereby annexed to the City of Price, County of Carbon, State of Utah, and the limits of said City of Price, Utah, are hereby extended to embrace the said real property which is particularly bounded and described as follows, to-wit:

Beginning at a point which is 720 feet South of the Northwest corner of Section 15, Township 14 South, Range 10 East of the Salt Lake Base and Meridian, and running thence South 661 feet; thence West 380.9 feet; thence North 661 feet; thence East 380.9 feet to the point of beginning.

The area so annexed consisting of block 15, Park Dale Township of Price, Utah, together with designated streets bounding said block 15 on the East and South sides thereof.

SECTION II. That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this ordinance, are, to the extent of such conflict, hereby repealed.

SECTION III. That in the opinion of the City Council of Price City, Utah, it is necessary to the peace, health, and safety of said city that this ordinance shall take effect immediately upon its passage, adoption and publication.

Passed and adopted by the City Council of Price City, County of Carbon, State of Utah, and approved by the Mayor this 8th day of October, A.D., 1956.
