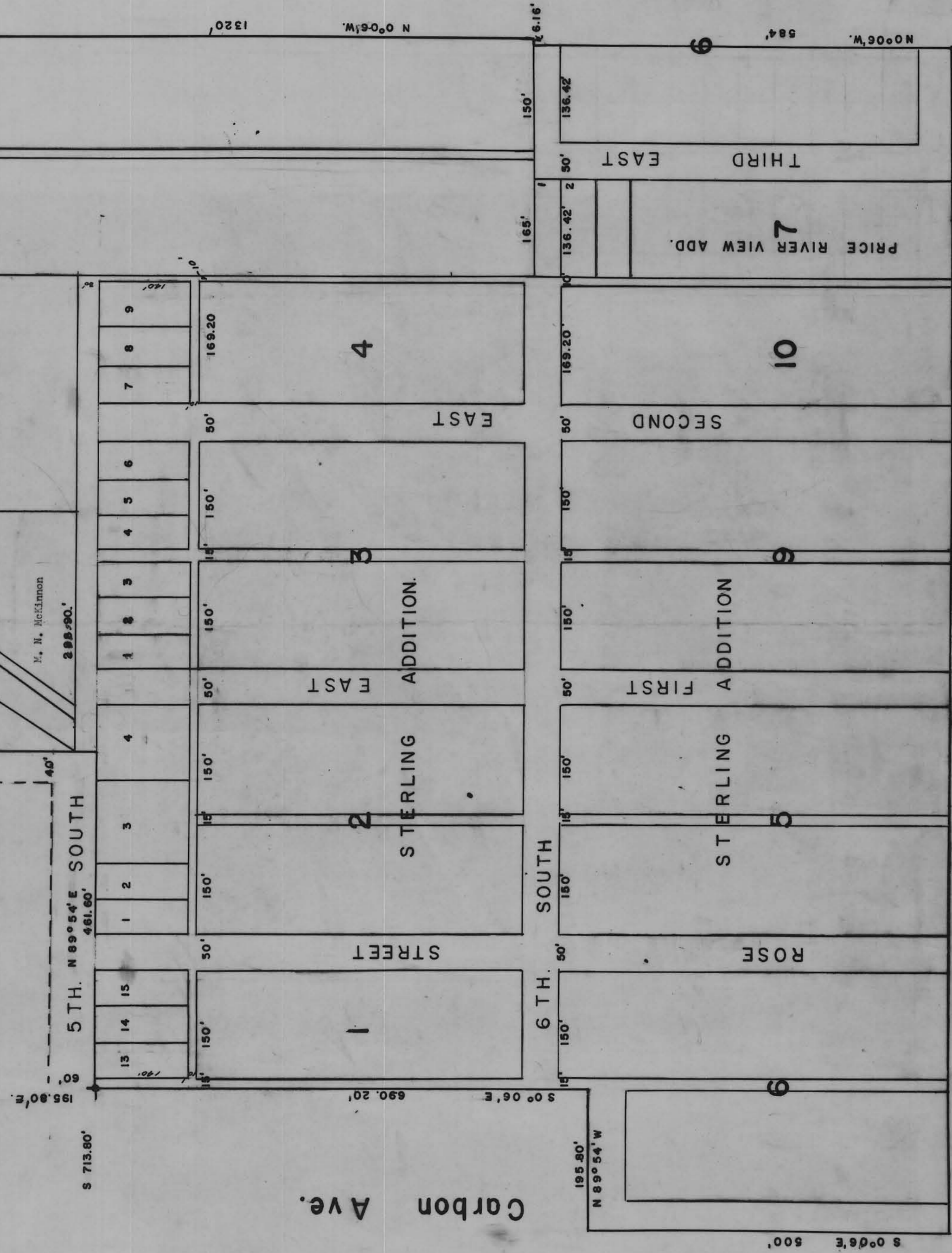

ENGINEER'S CERTIFICATE
 I, John Bane, a civil engineer of Price, Utah do hereby certify that by authority given me by Price City, I have surveyed and platted the following described tract of land to be incorporated within the boundaries of Price City:

Beginning at a point which is South 0°06' East 713.80 ft. and 195.80 ft. East from the Northeast Corner of the North-east quarter of the Southwest quarter of Section 21, Township 14 South, Range 10 East, and 20 feet East of the corner of the 195.80 feet; thence South 0°06' East 500 ft.; thence North 89°54' West 195.80 feet; thence South 0°06' East 500 ft.; thence North 89°54' East 161.28 feet; thence North 0°06' East 1320 feet; thence East 6.16 feet; thence North 89°54' East 1320 feet; thence South 89°54' West 922.60 feet; thence South 0°06' East 713.80 feet; thence South 89°54' West 461.60 feet more or less to the point of beginning.
