ALONG THE ARC OF A 558.366 FT. 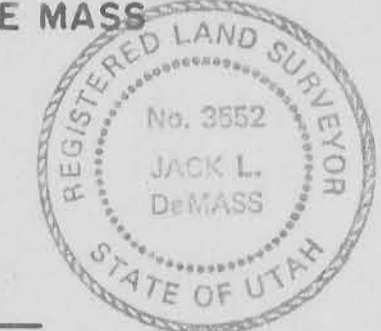
